## A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 5C of Title 48 of the Official Code of Georgia Annotated, relating to
- 2 alternative ad valorem tax on motor vehicles, so as to provide that the transfer of a title
- 3 between legal entities owned by the same person does not constitute a taxable event; to
- 4 provide for related matters; to repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

- 7 Chapter 5C of Title 48 of the Official Code of Georgia Annotated, relating to alternative ad
- 8 valorem tax on motor vehicles, is amended by revising paragraph (15) of subsection (d) of
- 9 Code Section 48-5C-1, relating to definitions, exemption from taxation, allocation and
- 10 disbursement of proceeds collected by tag agents, fair market value of vehicle appealable,
- 11 and report, as follows:

- "(15) There shall be no liability for any state or local title ad valorem tax fees in any ofthe following title transactions:
- 14 (A) The addition or substitution of lienholders on a motor vehicle title so long as the owner of the motor vehicle remains the same;
- 16 (B) The acquisition of a bonded title by a person or entity pursuant to Code
- 17 Section 40-3-28 if the title is to be issued in the name of such person or entity;
- 18 (C) The acquisition of a title to a motor vehicle by a person or entity as a result of the
- 19 foreclosure of a mechanic's lien pursuant to Code Section 40-3-54 if such title is to be
- issued in the name of such lienholder:
- 21 (D) The acquisition of a title to an abandoned motor vehicle by a person or entity
- pursuant to Chapter 11 of Title 40 if such person or entity is a manufacturer or dealer
- of motor vehicles and the title is to be issued in the name of such person or entity;

26	(F) The obtaining of a title by and in the name of a motor vehicle manufacturer,
27	licensed distributor, licensed dealer, or licensed rebuilder for the purpose of sale or
28	resale or to obtain a corrected title, provided that the manufacturer, distributor, dealer,
29	
	or rebuilder shall submit an affidavit in a form promulgated by the commissioner
30	attesting that the transfer of title is for the purpose of accomplishing a sale or resale or
31	to correct a title only;
32	(G) The obtaining of a title by and in the name of the holder of a security interest when
33	a motor vehicle has been repossessed after default in accordance with Part 6 of Article 9 $$
34	of Title 11 if such title is to be issued in the name of such security interest holder;
35	(H) The obtaining of a title by a person or entity for purposes of correcting a title,
36	changing an odometer reading, or removing an odometer discrepancy legend, provided
37	that, subject to subparagraph (F) of this paragraph, title is not being transferred to
38	another person or entity;
39	(I) The obtaining of a title by a person who pays state and local title ad valorem tax
40	fees on a motor vehicle and subsequently moves out of this state but returns and applies
41	to retitle such vehicle in this state;
42	(J) The obtaining of a replacement title on a vehicle that is not less than 15 years old
43	upon sufficient proof provided to the commissioner that such title no longer exists;
44	(K) The transfer of a title made as a result of a business reorganization when the
45	owners, partners, members, or stockholders of the business being reorganized maintain
46	the same proportionate interest or share in the newly formed business reorganization;
47	(L) The transfer of a title from a company to an owner of the company for the purpose
48	of such individual obtaining a prestige or special license plate for the motor vehicle;
49	and
50	(M) The transfer of a title from an owner of a company to the company; and
51	(N) The transfer of a title between legal entities owned by the same person."

52 SECTION 2.

All laws and parts of laws in conflict with this Act are repealed.
