BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Health - General 13-3301. In this subtitle the following words have the meanings indicated. (a) "Certifying provider" means an individual who: (d) (i) Has an active, unrestricted license to practice medicine (1)1.
