## STATE OF ALASKA 2019 LEGISLATIVE SESSION

#### Analysis

This legislation amends AS 14.03.080, Right to attend school, by adding a new subsection (g) that would require a school district to consider a student whose parent is a member of the armed forces as a resident and admit the student to a public school. The parent would be required to provide to the school district written proof of residence on an official document within 10 days after the arrival date stated in the military orders. This legislation also provides definitions of a "military installation" and "residence".

There is no fiscal impact to the Department of Education & Early Development under this legislation.
