# 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 19 That the Laws of Maryland read as follows:

if applicable, on the economic development programs administered by the Department:

- 24 (i) the number of jobs created;
- 25 (ii) the number of jobs retained;
- 26 (iii) the estimated amount of State revenue generated;
