AN ACT

To modify the boundary of the Little Rock Central High School National Historic Site, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Little Rock Central
3 High School National Historic Site Boundary Modifica-
4 tion Act”.

5 **SEC. 2. LITTLE ROCK CENTRAL HIGH SCHOOL NATIONAL**
6 **HISTORIC SITE BOUNDARY MODIFICATION.**

7 Section 2 of Public Law 105–356 (112 Stat. 3268)
8 is amended—

9 (1) by redesignating subsections (b), (c), (d),
10 and (e) as subsections (c), (d), (e), and (f), respec-
11 tively;

12 (2) by inserting after subsection (a) the fol-
13 lowing:

14 “(b) BOUNDARY MODIFICATION.—The boundary of
15 the historic site is modified to include the 7 residences
16 on South Park Street in Little Rock, Arkansas, consisting
17 of 1.47 acres, as generally depicted on the map entitled
18 ‘Central High School National Historic Site Proposed
19 Boundary’, numbered 037/80,001, and dated August,
20 2004.”; and

21 (3) in subsection (d) (as redesignated by para-
22 graph (1))—

23 (A) in paragraph (1), by striking “(1) The
24 Secretary” and inserting the following:

25 “(1) IN GENERAL.—The Secretary”;

1 (B) in paragraph (2), by striking “(2) The
2 Secretary” and inserting the following:

3 “(3) COORDINATION.—The Secretary”; and

4 (C) by inserting after paragraph (1) the
5 following:

6 “(2) COOPERATIVE AGREEMENTS FOR THE
7 PRESERVATION AND INTERPRETATION OF CERTAIN
8 PROPERTIES.—

9 “(A) IN GENERAL.—The Secretary may
10 enter into cooperative agreements with the own-
11 ers of the 7 residences referred to in subsection
12 (b) pursuant to which the Secretary may use
13 appropriated funds to mark, interpret, improve,
14 restore, and provide technical assistance with
15 respect to the preservation and interpretation of
16 the properties.

17 “(B) INCLUSIONS.—An agreement entered
18 into under subparagraph (A) shall include a
19 provision specifying that no changes or alter-
20 ations shall be made to the exterior of the prop-
21 erties subject to the agreement, except by the

1 mutual agreement of the parties to the agree-
2 ment.”.
