## A BILL

To amend title 18, United States Code, to permit uniformed law enforcement officers to carry agency-issued firearms in certain Federal facilities, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Protecting Officers of
- 5 the Law In Civilian Establishments Act of 2019" or as
- 6 the "POLICE Act of 2019".

1	SEC. 2. PERMITTING UNIFORMED LAW ENFORCEMENT OF-
2	FICERS TO CARRY AGENCY-ISSUED FIRE-
3	ARMS.
4	Section 930 of title 18, United States Code, is
5	amended—
6	(1) in subsection (d)—
7	(A) in paragraph (2), by striking "or" at
8	the end;
9	(B) in paragraph (3), by striking the pe-
10	riod at the end and inserting "; or"; and
11	(C) by adding at the end the following:
12	"(4) the lawful carrying of agency-issued fire-
13	arms and other dangerous weapons in Facility Secu-
14	rity Level I and II Federal civilian public access fa-
15	cilities by a uniformed officer, agent, or employee of
16	the United States, a State, or a political subdivision
17	thereof, who is authorized by law to engage in or su-
18	pervise the prevention, detection, investigation, or
19	prosecution of any violation of law."; and
20	(2) in subsection (g), by adding at the end the
21	following:
22	"(4) The term 'Facility Security Level' means
23	a security risk assessment level assigned to a Fed-
24	eral facility by the facility's security agency in ac-
25	cordance with the biannually issued Interagency Se-
26	curity Committee Standard.

1	"(5) 「	The term	'civilian	public	access	facility'
2	means a fac	cility open	to the g	eneral p	ublic.	

"(6) The term 'uniformed officer, agent, or employee' means an officer, agent, or employee wearing a clearly identifiable agency standard-issued uniform with a clearly identifiable agency-issued identification badge.".
