## A BILL

To provide public health veterinary services to Indian Tribes and Tribal organizations for rabies prevention, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterinary Services  
5 to Improve Public Health in Rural Communities Act”.

1 **SEC. 2. FINDINGS; SENSE OF CONGRESS.**

2 (a) FINDINGS.—Congress finds that—

3 (1) human, animal, and environmental health  
4 are interdependent in Native communities, Alaska  
5 Native villages, and on Indian reservations, and ho-  
6 listic approaches to the well-being of all individuals  
7 will lead to improved health outcomes and enhanced  
8 resilience;

9 (2) uncontrolled animal populations and a lack  
10 of veterinary care in Native communities, Alaska  
11 Native villages, and on Indian reservations increase  
12 the risk of parasites and zoonotic diseases, dog bites,  
13 food insecurity, and mental health issues among  
14 Alaska Natives and American Indians;

15 (3) dog bites and other injuries are common in  
16 rural areas in the State of Alaska, with the Norton  
17 Sound Health Corporation reporting an average of  
18 87 bites per year in the Bering Strait region be-  
19 tween 2016 and 2023, and the Yukon-Kuskokwim  
20 Health Corporation reporting an average of 98 bites  
21 per year in the Yukon-Kuskokwim Delta region be-  
22 tween 2008 and 2017;

23 (4) Alaska Native children have the highest in-  
24 cidence of hospitalization for dog bites in the Indian  
25 Health Service system;

1 (5) in 2021, St. Lawrence Island, Alaska, experi-  
2 enced co-occurring outbreaks of rabies and canine  
3 distemper;

4 (6) canine distemper is almost 100 percent  
5 fatal in marine mammals, which the people of the  
6 Native Villages of Savoonga and Gambell rely on  
7 heavily as a food source;

8 (7) rabies is enzootic in arctic and red fox pop-  
9 ulations in the northern and western coastal regions  
10 of the State of Alaska;

11 (8) wildlife outbreaks occur cyclically, and there  
12 have been increased human exposures to rabid ani-  
13 mals between 2020 and 2023;

14 (9) rabies transmission is a significant threat in  
15 Alaska Native communities and villages; and

16 (10) as of 2024, the Indian Health Service does  
17 not employ or use public health veterinarians to  
18 combat zoonotic disease outbreaks or to generally  
19 advance public health preparedness for Native com-  
20 munities, Alaska Native villages, or Indian reserva-  
21 tions, including by providing spay and neuter serv-  
22 ices and vaccinations for animals.

23 (b) SENSE OF CONGRESS.—It is the sense of Con-  
24 gress that the Indian Health Service of the Department  
25 of Health and Human Services is uniquely suited to em-

1 power Indian Tribes and Tribal organizations to address  
2 zoonotic disease threats in the communities they serve by  
3 providing public health veterinary services through a One  
4 Health approach that recognizes the interconnection be-  
5 tween people, animals, plants, and their shared environ-  
6 ment.

7 **SEC. 2. SENSE OF CONGRESS.**

8 *It is the sense of Congress that the Indian Health Serv-*  
9 *ice of the Department of Health and Human Services is*  
10 *uniquely suited to empower Indian Tribes and Tribal orga-*  
11 *nizations to address zoonotic disease threats in the commu-*  
12 *nities they serve by providing public health veterinary serv-*  
13 *ices through a One Health approach that recognizes the*  
14 *interconnection between people, animals, plants, and their*  
15 *shared environment.*

16 **SEC. 3. PUBLIC HEALTH VETERINARY SERVICES.**

17 Title II of the Indian Health Care Improvement Act  
18 is amended by inserting after section 223 (25 U.S.C.  
19 1621v) the following:

20 **“SEC. 224. PUBLIC HEALTH VETERINARY SERVICES.**

21 “(a) DEFINITIONS.—In this section:

22 “(1) PUBLIC HEALTH VETERINARY SERV-  
23 ICES.—The term ‘public health veterinary services’  
24 includes any of the following:

1           “(A) spaying and neutering services for do-  
2           mestic animals;

3           “(B) diagnoses;

4           “(C) surveillance;

5           “(D) epidemiology;

6           “(E) control;

7           “(F) prevention;

8           “(G) elimination;

9           “(H) vaccination; and

10           “(I) any other related service or activity  
11           that reduces the risk of zoonotic disease trans-  
12           mission or antimicrobial resistance in humans,  
13           food, or animals.

14           “(2) ZOONOTIC DISEASE.—The term ‘zoonotic  
15           disease’ means a disease or infection that may be  
16           transmitted naturally from vertebrate animals to hu-  
17           mans, or from humans to vertebrate animals.

18           “(b) AUTHORIZATION FOR VETERINARY SERVICES.—  
19           The Secretary, acting through the Service, may expend  
20           funds, directly or pursuant to the Indian Self-Determina-  
21           tion and Education Assistance Act (25 U.S.C. 5301 et  
22           seq.), for public health veterinary services to prevent and  
23           control of zoonotic disease infection and transmission in  
24           Service areas where the risk for disease occurrence in hu-  
25           mans and wildlife is endemic.

1       “~~(e)~~ PUBLIC HEALTH OFFICERS.—In providing pub-  
 2 lie health veterinary services under subsection (b), the Sec-  
 3 retary shall deploy veterinary public health officers from  
 4 the Commissioned Corps of the Public Health Service to  
 5 Service areas.

6       “~~(d)~~ COORDINATION.—The Secretary, acting through  
 7 the Service, shall carry out this section in coordination  
 8 with—

9               “~~(1)~~ the Director of the Centers for Disease  
 10 Control and Prevention; and

11              “~~(2)~~ the Secretary of Agriculture.

12       “~~(c)~~ PUBLIC HEALTH OFFICERS; COORDINATION.—*In*  
 13 *providing public health veterinary services under subsection*  
 14 *(b), the Secretary may—*

15              “*(1) assign or deploy veterinary public health of-*  
 16 *ficers from the Commissioned Corps of the Public*  
 17 *Health Service to Service areas; and*

18              “*(2) coordinate and implement activities with—*

19                      “*(A) the Director of the Centers for Disease*  
 20 *Control and Prevention; and*

21                      “*(B) the Secretary of Agriculture.*

22       “~~(e)(d)~~ REPORT.—The Secretary shall submit to the  
 23 Committee on Indian Affairs of the Senate, the Committee  
 24 on Health, Education, Labor, and Pensions of the Senate,  
 25 the Committee on Natural Resources of the House of Rep-

1 representatives, and the Committee on Energy and Commerce  
2 of the House of Representatives a biennial report on the  
3 use of funds, the assignment and deployment of veterinary  
4 public health officers from the Commissioned Corps of the  
5 Public Health Service, data related to the monitoring and  
6 disease surveillance of zoonotic diseases, and related serv-  
7 ices provided under this section.”.

8 **SEC. 4. APHIS WILDLIFE SERVICES STUDY ON ORAL RABIES**  
9 **VACCINES IN ARCTIC REGIONS OF THE**  
10 **UNITED STATES.**

11 Not later than 1 year after the date of enactment  
12 of this Act, the Secretary of Agriculture shall conduct a  
13 feasibility study—

14 (1) on the delivery of oral rabies vaccines to  
15 wildlife reservoir species that are directly or indi-  
16 rectly connected to the transmission of rabies to  
17 Tribal members living in Arctic regions of the  
18 United States; and

19 (2) that—

20 (A) evaluates the efficacy of the vaccines  
21 described in paragraph (1); and

22 (B) makes recommendations to improve  
23 the delivery of those vaccines.

1 **SEC. 5. ONE HEALTH FRAMEWORK.**

2       Section 2235(b) of the Prepare for and Respond to  
3 Existing Viruses, Emerging New Threats, and Pandemics  
4 Act (42 U.S.C. 300hh–37(b)) is amended by striking “and  
5 the Secretary of the Interior” and inserting “, the Sec-  
6 retary of the Interior, and the Director of the Indian  
7 Health Service”.
