2	Voice Over Internet Protocol – Robocalls – Customer Information
3	FOR the purpose of requiring a voice over Internet protocol (VoIP) service provider to obtain
4	certain information from a person making certain robocalls through the VoIP service
5	provider; providing that a person who willfully violates certain provisions is subject

14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.
15	That the Laws of Maryland read as follows:

- 17 SUBTITLE 22A. VOIP ROBOCALLS.
- 18 **14-22A-01.**
- 19 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS 20 INDICATED.
- 21 (B) (1) "AUTOMATIC DIALER" MEANS EQUIPMENT OR SOFTWARE THAT

- 1 MAKES A SERIES OF CALLS TO STORED TELEPHONE NUMBERS, INCLUDING NUMBERS
- 2 STORED ON A LIST.
- 3 (2) "AUTOMATIC DIALER" DOES NOT INCLUDE EQUIPMENT THAT
- 4 REQUIRES A HUMAN TO DIAL OR PLACE EACH INDIVIDUAL CALL ONE CALL AT A TIME,
- 5 AND REQUIRES THE HUMAN TO THEN REMAIN ON EACH CALL.
- 6 (C) "PERSON" INCLUDES AN INDIVIDUAL, CORPORATION, BUSINESS TRUST,
- 7 STATUTORY TRUST, ESTATE, TRUST, PARTNERSHIP, ASSOCIATION, TWO OR MORE
- 8 PERSONS HAVING A JOINT OR COMMON INTEREST, OR ANY OTHER LEGAL OR
- 9 COMMERCIAL ENTITY.
- 10 (D) "ROBOCALL" MEANS A CALL MADE, INCLUDING A TEXT MESSAGE SENT,
- 11 TO ANY TELEPHONE NUMBER OWNED BY A PERSON IN THE STATE USING:
- 12 (1) AN AUTOMATIC DIALER; OR
- 13 (2) AN ARTIFICIAL OR PRERECORDED VOICE.
- 14 (E) "VOICE OVER INTERNET PROTOCOL" OR "VOIP" HAS THE MEANING
- 15 STATED IN § 8–601 OF THE PUBLIC UTILITIES ARTICLE.
- 16 **14–22A–02**.
- 17 A VOIP SERVICE PROVIDER THAT IS LOCATED IN THE STATE SHALL OBTAIN
- 18 FROM A PERSON PLACING ROBOCALLS THROUGH THE VOIP SERVICE PROVIDER
- 19 THE FOLLOWING IDENTIFYING INFORMATION:
- 20 (1) THE PERSON'S LEGAL NAME AND THE NAME BY WHICH THE
- 21 PERSON DOES BUSINESS;
- 22 (2) CONTACT INFORMATION;
- 23 (3) THE PHYSICAL LOCATION OF THE PRIMARY PLACE OF BUSINESS;
- 24 (4) IF APPLICABLE, THE STATE OR COUNTRY OF INCORPORATION;
- 25 (5) THE FEDERAL TAX ID, IF ANY; AND
- 26 (6) THE NATURE OF THE PERSON'S BUSINESS.

- 1 A PERSON WHO WILLFULLY VIOLATES THE REQUIREMENTS OF THIS SUBTITLE 2 IS LIABLE TO A CIVIL PENALTY OF \$500 FOR EACH ROBOCALL MADE.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 4 October 1, 2020.
