A BILL

To amend title IV of the Public Health Service Act to prohibit sale or transactions relating to human fetal tissue.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- **3** SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Prohibiting Abortion
- 5 Industry's Lucrative Loopholes Act".

1	SEC. 2. PROHIBITING SALE OR TRANSACTIONS RELATING
2	TO HUMAN FETAL TISSUE.
3	Section $498B(e)$ of the Public Health Service Act (42
4	U.S.C. 289–2(e)) is amended by striking paragraph (3)
5	and inserting the following new paragraph:
6	"(3) The term 'valuable consideration' in-
7	cludes—
8	"(A) any payment made or debt incurred;
9	"(B) any gift, honorarium, or recognition
10	of value bestowed;
11	"(C) any price, charge, or fee which is
12	waived, forgiven, reduced, or indefinitely de-
13	layed;
14	"(D) any loan or debt which is canceled or
15	otherwise forgiven;
16	"(E) the transfer of any item from one
17	person to another or provision of any service or
18	granting of any opportunity for which a charge
19	is customarily made, without charge or for a re-
20	duced charge; and
21	"(F) any payments associated with the
22	transportation, implantation, processing, preser-
23	vation, quality control, or storage of human
24	fetal tissue.".
