A BILL TO BE ENTITLED AN ACT

- To amend Part 3 of Article 3 of Chapter 11 of Title 16 of the Official Code of Georgia 1
- 2 Annotated, relating to invasion of privacy, so as to include falsely created videographic or
- 3 still images of other persons within the prohibition against the transmission of photography
- 4 or videos depicting nudity or sexually explicit conduct of another person under certain
- 5 circumstances; to provide for related matters; to provide for an effective date and
- applicability; to repeal conflicting laws; and for other purposes. 6

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

- 9 Part 3 of Article 3 of Chapter 11 of Title 16 of the Official Code of Georgia Annotated,
- relating to invasion of privacy, is amended by revising subsection (b) of Code 10
- 11 Section 16-11-90, relating to prohibition on nude or sexually explicit electronic
- 12 transmissions, as follows:

- 13 "(b) A person violates this Code section if he or she, knowing the content of a transmission 14
- or post, knowingly and without the consent of the depicted person:
- 15 (1) Electronically transmits or posts, in one or more transmissions or posts, a photograph
- 16 or video which depicts nudity or sexually explicit conduct of an adult, including a falsely
- 17 <u>created videographic or still image</u>, when the transmission or post is harassment or causes
- 18 financial loss to the depicted person and serves no legitimate purpose to the depicted
- 19 person; or
- 20 (2) Causes the electronic transmission or posting, in one or more transmissions or posts,
- 21 of a photograph or video which depicts nudity or sexually explicit conduct of an adult.
- including a falsely created videographic or still image, when the transmission or post is 22
- harassment or causes financial loss to the depicted person and serves no legitimate 23
- 24 purpose to the depicted person.
- 25 Nothing in this Code section shall be construed to impose liability on an interactive
- computer service, as such term is defined in 47 U.S.C. 230(f)(2), or an information service 26
