## A BILL

To direct the Federal Communications Commission to revise its sponsorship identification rules so as to require the disclosure of the names of significant donors to persons paying for or furnishing broadcast matter or origination cablecasting matter that is political matter or matter involving the discussion of a controversial issue of public importance.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Keeping Our Cam-  
5       paigns Honest Act of 2017”.

6       **SEC. 2. REVISION TO SPONSORSHIP IDENTIFICATION**  
7               **RULES.**

8       Not later than 90 days after the date of the enact-  
9       ment of this Act, the Federal Communications Commis-  
10      sion shall revise its sponsorship identification rules (sec-  
11      tions 73.1212 and 76.1615 of title 47, Code of Federal  
12      Regulations) so as to provide that, in the case of broadcast  
13      matter or origination cablecasting matter that is political  
14      matter or matter involving the discussion of a controver-  
15      sial issue of public importance, the announcement required  
16      by such sections shall include the names of significant do-  
17      nors to the person the identity of which is required to be  
18      disclosed in such announcement.
