23	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
24	Section 1. The following words and phrases shall

boundaries of the county less and except the area lying within
 the corporate limits of the City of Pike Road.

(9) SPECIAL AD VALOREM TAX. The special ad valorem
tax authorized in Amendment No. 382 of the Constitution of
Alabama of 1901, to be levied and collected at the rate of 3
mills on taxable property in the district, subject to approval
by the electorate as provided by the laws of Alabama.

8 Section 2. Montgomery County presently is authorized to levy and collect the special ad valorem tax at a rate of 9 10 \$.30 on each one hundred dollars (3 mills on each dollar) of assessed value pursuant to Amendment No. 382 subject to 11 approval by the electorate as provided by the laws of this 12 13 state. Pursuant to a resolution adopted by the county commission in accordance with Amendment No. 373, Montgomery 14 15 County proposes to increase the rate at which it may levy and collect the special ad valorem tax in the district to a 16 maximum rate, for any tax year, which is equal to \$1.85 on 17 18 each one hundred dollars (18.5 mills on each dollar) of assessed value. 19

20 Section 3. Pursuant to subsection (f) of Amendment 21 No. 373 and a resolution adopted by the county commission 22 after a public hearing, the county commission may increase the 23 rate at which the county may levy and collect the special ad 24 valorem tax in the district to a maximum rate, for any tax 25 year, which is equal to \$1.85 on each one hundred dollars 26 (18.5 mills on each dollar) of assessed value, the levy and collection at such rate to be in lieu of the levy and 27

collection of any district tax under the provisions of either
 Section 2 of Amendment No. 3 or Amendment No. 778.

3 Section 4. The increase in the rate at which the 4 special ad valorem tax may be levied and collected pursuant to 5 this act is subject to the approval of a majority of the 6 qualified electors residing in the district who vote on the 7 proposed levy at a special election called and held for such 8 purpose pursuant to the provisions of subsection (f) of 9 Amendment No. 373.

10 Section 5. This act shall become effective 11 immediately following its passage and approval by the 12 Governor, or its otherwise becoming law.
