## **3** SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Alzheimer's Caregiver

| 17 | "(2) Medically underserved community.—                       |
| 18 | The term 'medically underserved community' has the           |
| 19 | meaning given the term in section 799B.                      |
| 20 | "(b) GRANTS.—The Secretary may award grants to               |
| 21 | public or nonprofit private health care and social service   |
| 22 | providers described in subsection (c) for the purpose of     |
| 23 | expanding training and support services for families and     |
| 24 | unpaid caregivers of people living with Alzheimer's disease  |

"(1) in any program to be funded by a grant
awarded under subsection (b), that services will be
provided in the languages most appropriate for, and
with consideration for the cultural backgrounds of,
the individuals for whom the services are provided;

7 "(2) to provide outreach activities to inform the
8 public of the services of the program, and to provide
9 information on Alzheimer's disease and related de10 mentias to the public.

11 "(e) COORDINATION.—The Secretary shall coordinate 12 with the Director of the Office on Women's Health and 13 the Director of the Office of Minority Health in order to 14 ensure that women, minorities, and patients who live in 15 medically underserved communities are able to benefit 16 from the training and support services funded through 17 grants awarded under subsection (b).

18 "(f) FUNDING.—

19 "(1) AUTHORIZATION OF APPROPRIATIONS.—
20 For the purpose of carrying out this section, there
21 are authorized to be appropriated such sums as may
22 be necessary for each of fiscal years 2021 through
23 2025.

24 "(2) ALLOCATION FOR MEDICALLY UNDER25 SERVED COMMUNITIES.—Of the amounts appro-

priated under paragraph (1) for a fiscal year, the Secretary shall make available not less than 10 percent for grants awarded under subsection (b) to public or nonprofit private health care and social service providers that primarily serve medically underserved communities and meet the requirements under this section.".
