# Worcester County – Special Event Zones – Prohibitions

- FOR the purpose of prohibiting a person from engaging in exhibition driving within a
  special event zone in Worcester County; prohibiting a person from committing
  certain violations of the Maryland Vehicle Law within a special event zone in
  Worcester County; defining the term "exhibition driving" for purposes of this Act;
  establishing certain penalties for violations of this Act; altering a certain definition;
  making stylistic changes; making this Act an emergency measure; and generally
  relating to special event zones in Worcester County.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

1 (4) (I) "SPECIAL EVENT ZONE" MEANS AN AREA ON OR ALONG A 2 HIGHWAY THAT IS MARKED BY APPROPRIATE WARNING SIGNS OR OTHER TRAFFIC 3 CONTROL DEVICES DESIGNATING THE AREA AS A SPECIAL EVENT ZONE AND, 4 INDICATING THAT A SPECIAL EVENT IS IN PROGRESS, AND STATING THAT A PERSON 5 WHO VIOLATES THIS SECTION IS SUBJECT TO ARREST.

6 (II) "SPECIAL EVENT ZONE" INCLUDES A PARKING STRUCTURE,
7 A PARKING LOT, A STREET, OR ANY OTHER PROPERTY, PRIVATE OR PUBLIC,

12(I)DESIGNATE AN AREA ON A STATE HIGHWAY AS A SPECIAL13EVENT ZONE; AND

14 (II) REDUCE ESTABLISHED SPEED LIMITS IN THE SPECIAL 15 EVENT ZONE AFTER A DETERMINATION THAT THE CHANGE IS NECESSARY TO 16 ENSURE PUBLIC SAFETY.

17 (2) A LOCAL AUTHORITY MAY:

18(I) DESIGNATE AN AREA ON A HIGHWAY UNDER ITS19JURISDICTION AS A SPECIAL EVENT ZONE; AND

1 (3) DRIVING A MOTOR VEHICLE IN A RACE OR SPEED CONTEST UNDER 2 § 21–1116(A) OF THIS TITLE THAT DOES NOT RESULT IN SERIOUS BODILY INJURY TO 3 ANOTHER PERSON, AS DEFINED IN § 20–102(C) OF THIS ARTICLE;

- 4 (4) PARTICIPATING IN A RACE OR SPEED CONTEST UNDER § 5 21–1116(B) OF THIS TITLE; OR
- 6 (5) SKIDDING, SPINNING OF WHEELS, OR CAUSING EXCESSIVE NOISE 7 UNDER § 21–1117 OF THIS TITLE.
- 8 (F) (1) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (E) (D) OF 9 THIS SECTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 60 DAYS OR A FINE 10 NOT EXCEEDING \$1,000 OR BOTH.
- 11 (2) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (F) (E) OF 12 THIS SECTION IS SUBJECT TO A FINE NOT EXCEEDING \$1,000.
- 13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency 14 measure, is necessary for the immediate preservation of the public health or safety, has 15 been passed by a yea and nay vote supported by three—fifths of all the members elected to 16 each of the two Houses of the General Assembly, and shall take effect from the date it is 17 enacted.
