#### A BILL ENTITLED

#### 1 AN ACT concerning

## 2 Child Care Centers – Employee Qualifications – Requirements and Application 3 Review

4 FOR the purpose of requiring the regulations adopted by the State Board of Education to  $\mathbf{5}$ govern the licensing and operation of child care centers to include provisions that 6 establish certain gualifications for child care teachers and require each child care 7 center employee to complete certain training within a certain number of days after 8 the individual is hired; requiring the State Department of Education to review an 9 individual's qualifications for employment in a child care center and approve or deny the application within a certain period of time; and generally relating to the 10 11 qualifications of child care center employees.

# WITHIN 14 DAYS AFTER RECEIVING A COMPLETE APPLICATION, THE DEPARTMENT SHALL REVIEW AN INDIVIDUAL'S QUALIFICATIONS FOR EMPLOYMENT IN A CHILD CARE CENTER AND APPROVE OR DENY THE APPLICATION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2020.
