A BILL

To require the Secretary of Homeland Security to conduct a review of the ability of the Cybersecurity and Infrastructure Security Agency of the Department of Homeland Security to fulfill its current mission requirements, and for other purposes.

1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Strengthening the Cy-							
3	bersecurity and Infrastructure Security Agency Act of							
4	2020".							
5	SEC. 2. CYBERSECURITY AND INFRASTRUCTURE SECURITY							
6	AGENCY REVIEW.							
7	(a) In General.—The Director of the Cybersecurity							
8	and Infrastructure Security Agency of the Department of							
9	Homeland Security shall conduct a review of the ability							
10	of the Cybersecurity and Infrastructure Security Agency							
11	to carry out its mission requirements, as well as the rec-							
12	ommendations detailed in the U.S. Cyberspace Solarium							
13	Commission's Report regarding the Agency.							
14	(b) Elements of Review.—The review conducted							
15	in accordance with subsection (a) shall include the fol-							
16	lowing elements:							
17	(1) An assessment of how additional budget re-							
18	sources could be used by the Cybersecurity and In-							
19	frastructure Security Agency for projects and pro-							
20	grams that—							
21	(A) support the national risk management							
22	mission;							
23	(B) support public and private-sector cy-							
24	bersecurity;							
25	(C) promote public-private integration; and							

1	(D) provide situational awareness of cyber-
2	security threats.
3	(2) A force structure assessment of the Cyber-
4	security and Infrastructure Security Agency, includ-
5	ing—
6	(A) a determination of the appropriate size
7	and composition of personnel to carry out the
8	mission requirements of the Agency, as well as
9	the recommendations detailed in the U.S.
10	Cyberspace Solarium Commission's Report re-
11	garding the Agency;
12	(B) as assessment of whether existing per-
13	sonnel are appropriately matched to the
14	prioritization of threats in the cyber domain
15	and risks to critical infrastructure;
16	(C) an assessment of whether the Agency
17	has the appropriate personnel and resources
18	to—
19	(i) perform risk assessments, threat
20	hunting, and incident response to support
21	both private and public cybersecurity;
22	(ii) carry out its responsibilities re-
23	lated to the security of Federal information
24	and Federal information systems (as such

1	term is defined in section 3502 of title 44,				
2	United States Code); and				
3	(iii) carry out its critical infrastruc-				
4	ture responsibilities, including national risk				
5	management;				
6	(D) an assessment of whether current				
7	structure, personnel, and resources of regional				
8	field offices are sufficient to carry out Agency				
9	responsibilities and mission requirements; and				
10	(E) an assessment of current Cybersecu-				
11	rity and Infrastructure Security Agency facili-				
12	ties, including a review of the suitability of such				
13	facilities to fully support current and projected				
14	mission requirements nationally and regionally,				
15	and recommendations regarding future facility				
16	requirements.				
17	(c) Submission of Review.—Not later than one				
18	year after the date of the enactment of this Act, the Sec-				
19	retary of Homeland Security shall submit to the Com-				
20	mittee on Homeland Security of the House of Representa-				
21	tives and the Committee on Homeland Security and Gov-				
22	ernmental Affairs of the Senate a report detailing the re-				
23	sult of the review conducted in accordance with subsection				
24	(a), including recommendations to address any identified				
25	gaps.
