1 AN ACT concerning

2 Public Health – Cottage Food Product Labels – Identification Number

FOR the purpose of altering the required contents of the label with which cottage food
products must be prepackaged to allow the inclusion of the phone number of the
cottage food business and a certain identification number, rather than the address
of the cottage food business; requiring the Maryland Department of Health to provide
a certain identification number to a cottage food business on request for a certain
purpose; and generally relating to cottage food product labels.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:
