3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Local Solutions to End

5 Homelessness Act of 2019".

6 SEC. 2. MINIMUM ALLOCATION REQUIREMENT FOR EMER-

GENCY SOLUTIONS GRANTS PROGRAM.

8 Section 414(b) of the McKinney-Vento Homeless As9 sistance Act (42 U.S.C. 11373(b)) is amended to read as
