A BILL

To require the Secretary of the Interior, the Secretary of Agriculture, and the Assistant Secretary of the Army for Civil Works to digitize and make publicly available geographic information system mapping data relating to public access to Federal land and waters for outdoor recreation, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Modernizing Access
- 5 to our Public Land Act" or the "MAPLand Act".

1 SEC. 2. FINDINGS.

| 3 | SEC. 3. DEFINITIONS. |
| 4 | In this Act: |
| 5 | (1) FEDERAL LAND.—The term "Federal land" |
| 6 | means any land or water managed by a Federal land |
| 7 | management agency. |
| 8 | (2) Federal land management agency.— |
| 9 | The term "Federal land management agency" |
| 10 | means— |
| 11 | (A) the Bureau of Reclamation; |
| 12 | (B) the National Park Service; |
| 13 | (C) the Bureau of Land Management; |
| 14 | (D) the United States Fish and Wildlife |
| 15 | Service; |
| 16 | (E) the Forest Service; and |
| 17 | (F) the Corps of Engineers. |
| 18 | (3) Secretaries.—The term "Secretaries" |

| 20 | (A) the Secretary of Agriculture; |

1 SEC. 4. INTERAGENCY DATA STANDARDIZATION.

| 8 | SEC. 5. DATA CONSOLIDATION, DIGITIZATION, AND PUBLI- |
| 9 | CATION. |
| 10 | (a) In General.—Not later than 3 years after the |
| 11 | date of enactment of this Act, each of the Secretaries, to |
| 12 | the maximum extent practicable, shall digitize and make |
| 13 | publicly available on the website of the Department of the |
| 14 | Interior, the Forest Service, and the Corps of Engineers, |
| 15 | as applicable, geographic information system mapping |
| 16 | data that includes, with respect to the Federal land ad- |
| 17 | ministered by the relevant Secretary— |
| 18 | (1) all Federal interests, including easements |
| 19 | and rights-of-way, in private land— |
| 20 | (A) to which the Federal Government does |
| 21 | not have a fee title interest; and |
| 22 | (B) that is used to provide recreational ac- |
| 23 | cess to the Federal land; |
| 24 | (2) status information with respect to whether |
| 25 | roads and trails on the Federal land are open or |
| 26 | closed; |

- 4 Not later than October 1 of each year—
- (1) each of the Secretary of the Interior and
 the Secretary of Agriculture shall submit to the
 Committee on Energy and Natural Resources of the
 Senate and the Committee on Natural Resources of
 the House of Representatives a report on the
 progress made by the Secretary of the Interior and
 the Secretary of Agriculture, respectively, toward
 meeting the requirements of section 5; and
