University of Maryland Eastern Shore – State Matching Funds for Land–Grant Institutions

FOR the purpose of requiring the Governor, beginning in a certain fiscal year, to include in 4 5 the annual State operating budget a general fund appropriation at least equal to a 6 certain amount to the University System of Maryland; requiring the Board of 7 Regents of the University System of Maryland to allocate certain funding to the 8 University of Maryland Eastern Shore in a certain manner and for a certain purpose; 9 providing that certain funding shall be in addition to certain base funding appropriated to the University of Maryland Eastern Shore and requiring certain 10 11 funding to be specified as a certain line item in the University's budget; requiring 12 the Board of Regents to provide certain information to the Governor on or before a 13 certain date each year; defining a certain term; and generally relating to State 14 matching funds for the University of Maryland Eastern Shore.

20 Preamble

WHEREAS, The designation as a land-grant institution applies collectively to those institutions that were established to promote the study of agriculture and the mechanical arts among all students, particularly those from working class populations; and

WHEREAS, 1862 land-grant institutions such as the University of Maryland, College Park are traditionally white institutions that were established with both land and funding to support this mission, while 1890 land-grant institutions, such as the University

WHEREAS, Both the University of Maryland, College Park and the University of Maryland Eastern Shore receive annual federal appropriations called formula funds that support Cooperative Extension, Agriculture Experiment Stations, and forestry research and extension from the U.S. Department of Agriculture National Institute of Food and Agriculture (USDA-NIFA); and

8 WHEREAS, While the 1862 program at the University of Maryland, College Park 9 has had a matching funding requirement since its inception, the 1890 program at the 10 University of Maryland Eastern Shore did not have a State matching fund requirement until the late 1990s; and

WHEREAS, Until 1997, only the 1862 land-grant institutions had to match the federal appropriations with State funds, but in 1997 requirements for matching were also assigned to the 1890 land-grant institutions; and

WHEREAS, The 1890 land-grant institution matching requirements were phased in and a 100% State match was required in full by fiscal year 2001; however, this has not occurred; and

WHEREAS, At a minimum, the total amount required to fully match the federal appropriation is \$3,057,408, and given the requirements under the Office of Management and Budget's uniform guidance at 2CFR200.306 implemented by USDA-NIFA through 2CFR400 as clarified in October 2016, the University of Maryland Eastern Shore will require \$1,955,235 in matching funds from the State in order to be fully compliant; and

WHEREAS, Without the State's support, the University of Maryland Eastern Shore is at a very real and serious risk of losing federal appropriations, which would lead to the demise of its agriculture and food teaching research and education programs; and

WHEREAS, The University of Maryland Eastern Shore manages the federal funding for agricultural and forestry research; however, since 1993, the federal funding available to support the University's extension programs has been managed centrally by the University of Maryland, College Park; and

WHEREAS, While both universities have continued to collaborate successfully under the auspices of the University of Maryland Extension, the arrangement established in 1993 places the University of Maryland Eastern Shore at a significant disadvantage and precludes growth and effectiveness in meeting local needs; and

WHEREAS, By enabling locally managed funding, the University of Maryland Eastern Shore's extension and research programs can continue to study a range of issues important to the Eastern Shore's agriculture community, including poultry production, the quality of water and forestry resources, the safety and quality of seafood, poultry, and fresh produce, and the impact of emerging technologies on agricultural productivity; and

WHEREAS, To ensure that the University of Maryland Eastern Shore is in the best position to provide services to its local community and manage the federal funds to which it is entitled, the State must designate a line item in the budget allocated specifically to the State match for federal funds; now, therefore,

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 6 That the Laws of Maryland read as follows:

- 9 (A) IN THIS SECTION, "FORMULA FUNDS" MEANS AGRICULTURAL
 10 EXTENSION FUNDS AND AGRICULTURAL RESEARCH FUNDS PROVIDED TO THE
 11 UNIVERSITY OF MARYLAND EASTERN SHORE UNDER SECTIONS 1444 AND 1445 OF
 12 THE NATIONAL AGRICULTURAL RESEARCH, EXTENSION, AND TEACHING POLICY

- (B) (1) FOR FISCAL YEAR 2019 AND EACH FISCAL YEAR THEREAFTER,
 THE GOVERNOR SHALL INCLUDE IN THE ANNUAL STATE OPERATING BUDGET FOR
 THE UNIVERSITY SYSTEM OF MARYLAND A GENERAL FUND APPROPRIATION AT
 LEAST EQUAL TO THE AMOUNT OF FORMULA FUNDS THE UNIVERSITY OF MARYLAND
 EASTERN SHORE IS PROJECTED TO RECEIVE DURING THAT FISCAL YEAR.
- 19 (2) ON OR BEFORE NOVEMBER 1, 2017, AND EACH NOVEMBER 1 20 THEREAFTER, THE BOARD OF REGENTS SHALL NOTIFY THE GOVERNOR OF THE 21 AMOUNT OF GENERAL FUNDS REQUIRED UNDER PARAGRAPH (1) OF THIS 22 SUBSECTION FOR THE UPCOMING FISCAL YEAR.
