A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act incorporating the City of McDonough, approved April 16, 1981

- 3 (Ga. L. 2012, p. 5452), so as to revise the corporate boundaries of the municipality; to
- 4 provide for related matters; to repeal conflicting laws; and for other purposes.

6 SECTION 1.

- 7 An Act incorporating the City of McDonough, approved April 16, 1981 (Ga. L. 1981,
- 8 p. 3387), as amended, particularly by an Act approved April 12, 2012 (Ga. L. 2012, p. 5452),
- 9 is amended by adding a new subsection to Section 1.11 to read as follows:
- 10 "(c) In addition to all areas presently within the corporate boundaries of the City of
- McDonough, the corporate boundaries shall include the following described territory:
