A BILL

To authorize the Society of the First Infantry Division to make modifications to the First Division Monument located on Federal land in Presidential Park in District of Columbia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “First Infantry Recogni-*
 5 *tion of Sacrifice in Theater Act” or the “FIRST Act”.*

6 **SEC. 2. MODIFICATION TO FIRST DIVISION MONUMENT.**

7 *(a) AUTHORIZATION.—The Society of the First Infan-*
 8 *try Division (an organization described in section 501(c)(3)*
 9 *of the Internal Revenue Code of 1986 and exempt from tax-*
 10 *ation under section 501(a) of that code), may make modi-*
 11 *fications (including construction of additional plaques and*
 12 *stone plinths on which to put the plaques) to the First Divi-*
 13 *sion Monument located on Federal land in President’s Park*
 14 *in the District of Columbia that was set aside for memorial*
 15 *purposes of the First Infantry Division, in order to honor*
 16 *the members of the First Infantry Division who paid the*
 17 *ultimate sacrifice during United States operations, includ-*
 18 *ing Operation Desert Storm, Operation Iraqi Freedom and*
 19 *New Dawn, and Operation Enduring Freedom. The First*
 20 *Infantry Division at the Department of the Army shall col-*
 21 *laborate with the Department of Defense to provide to the*
 22 *Society of the First Infantry Division the list of names to*
 23 *be added.*

24 *(b) NON-APPLICATION OF COMMEMORATIVE WORKS*
 25 *ACT.—Subsection (b) of section 8903 of title 40, United*

1 *States Code (commonly known as the “Commemorative*
2 *Works Act”)*, shall not apply to actions taken under sub-
3 *section (a) of this section.*

4 *(c) FUNDING.—Federal funds may not be used to pay*
5 *any expense of the activities of the Society of the First In-*
6 *fantry Division which are authorized by this section.*

Amend the title so as to read: “A bill to authorize the Society of the First Infantry Division to make modifications to the First Division Monument located on Federal Land in President’s Park in the District of Columbia, and for other purposes.”.
