## A BILL

To designate the Department of Veterans Affairs community-based outpatient clinic in Gilbert, Arizona, as the “Staff Sergeant Alexander W. Conrad Veterans Affairs Health Care Clinic”.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. FINDINGS.**

4       Congress finds the following:

5               (1) Staff Sergeant Alexander W. Conrad of  
6       Chandler, Arizona, joined the United States Army  
7       on June 1, 2010.

1           (2) Staff Sergeant Conrad’s decorated service  
2 includes two deployments to Afghanistan in support  
3 of Operation Enduring Freedom.

4           (3) Staff Sergeant Conrad subsequently de-  
5 ployed to Africa in support of Operation Octave  
6 Shield, while assigned to 1st Battalion, 3rd Special  
7 Forces Group, Fort Bragg, North Carolina, as a  
8 Human Intelligence Noncommissioned Officer.

9           (4) On June 8, 2018, Staff Sergeant Conrad  
10 died in Somalia from injuries sustained from indi-  
11 rect enemy fire.

12           (5) Staff Sergeant Conrad was posthumously  
13 awarded the Purple Heart, Bronze Star with Valor,  
14 and Meritorious Service Medal.

15 **SEC. 2. DESIGNATION OF STAFF SERGEANT ALEXANDER W.**

16 **CONRAD VETERANS AFFAIRS HEALTH CARE**  
17 **CLINIC.**

18           (a) DESIGNATION.—The Southeast Veterans Affairs  
19 Health Care Clinic located at 3285 South Val Vista Drive,  
20 Gilbert, Arizona, shall after the date of the enactment of  
21 this Act be known and designated as the “Staff Sergeant  
22 Alexander W. Conrad Veterans Affairs Health Care Clin-  
23 ic”.

24           (b) REFERENCE.—Any reference in a law, regulation,  
25 map, document, paper, or other record of the United

1 States to the facility referred to in subsection (a) shall  
2 be deemed to be a reference to the “Staff Sergeant Alex-  
3 ander W. Conrad Veterans Affairs Health Care Clinic”.
