A BILL ENTITLED

1 AN ACT concerning

2 Frederick County – Alcoholic Beverages – Municipal Golf Course License

3 FOR the purpose of establishing a Class M-G beer, wine, and liquor license for use at a 4 municipal golf course in Frederick County; authorizing the Board of License $\mathbf{5}$ Commissioners for Frederick County to issue the license to a manager of a municipal 6 golf course; specifying that the license authorizes the license holder to sell beer, wine, 7 and liquor for on-premises consumption on certain land and facilities used for golfing 8 purposes; authorizing the license holder to designate an agent for certain purposes; 9 providing that the agent shall be considered to be the vendor for certain purposes; authorizing the Board to transfer a license to a different golf course manager under 1011 certain circumstances; specifying the hours and days of sale; specifying a certain 12annual license fee; requiring the Board to adopt certain regulations; and generally 13 relating to alcoholic beverages licenses in Frederick County.
