## A BILL

To require the Secretary of the Interior to issue long-term leases on Federal lands under the administrative jurisdiction of the Bureau of Land Management to companies that relocate production facilities from the People's Republic of China to the United States, and for other purposes.

3 **SECTION 1. LONG-TERM LEASES FOR RELOCATION OF PRO-**

4 **DUCTION FACILITIES FROM THE PEOPLE'S**

5 **REPUBLIC OF CHINA.**

6 (a) LEASES AUTHORIZED.—

1           (1) IN GENERAL.—The Secretary of the Inte-  
2           rior shall issue long-term leases on Federal lands  
3           under the administrative jurisdiction of the Bureau  
4           of Land Management and deemed suitable for this  
5           purpose to companies that relocate production facili-  
6           ties from the People’s Republic of China to the  
7           United States.

8           (2) CERTIFICATION REQUIRED.—The Secretary  
9           of the Interior may only enter into a lease under this  
10          section after the Secretary of Commerce has cer-  
11          tified that the production facility to be located on  
12          the leased land will replace a production facility of  
13          the same size and type located in the People’s Re-  
14          public of China.

15         (b) TERMS AND CONDITIONS OF LEASES.—

16                 (1) TERM OF LEASE.—Leases under this sec-  
17                 tion shall be for a term of 99 years. If the produc-  
18                 tion facility relocated as a condition of a lease under  
19                 this section is relocated out of the United States be-  
20                 fore the expiration of the 99-year lease term, the  
21                 Secretary of Commerce may issue a fine to the leas-  
22                 ing company of an amount determined by that Sec-  
23                 retary.

24                 (2) FEE.—The rental fee for leases under this  
25                 section shall be \$1 per acre per year.

1           (3) USE OF LAND.—Land subject to a lease  
2           under this section may be used only for a production  
3           facility relocated from the People’s Republic of  
4           China. Such companies may construct facilities on  
5           such the land subject to the lease for the purposes  
6           of such production, in accordance with State and  
7           Federal law.
