## Income Tax Credit – Wages Paid to Qualified Veteran Employees (Hire Our Veterans Act of 2017)

- 4 FOR the purpose of allowing a credit against the State income tax for certain wages paid  $\mathbf{5}$ by certain small businesses to certain qualified veteran employees; providing for the 6 calculation of the credit; prohibiting a small business from claiming the credit under 7 certain circumstances; requiring the small business to submit certain documentation 8 to qualify for the credit; requiring the Department of Commerce, on application of a 9 small business, to issue a tax credit certificate under certain circumstances; requiring the application to contain certain information; requiring the Department 10 11 to approve applications on a first-come, first-served basis and notify applicants of approval or denial of an application within a certain number of days after receipt of 12 the application; providing that the total amount of tax credit certificates issued by 13 the Department may not exceed a certain amount for each taxable year; requiring 14the Department to report certain information to the Comptroller on or before a 1516 certain date each year; requiring the Department to adopt certain regulations; 17requiring the Secretary of Commerce to report to the General Assembly on or before 18 a certain date; defining certain terms; providing for the application of this Act; and 19 generally relating to a State income tax credit for wages paid to qualified veteran 20employees.
