A BILL ENTITLED

1 AN ACT concerning

2 Veterinary Practitioners – Animal Cruelty and Animal Fighting – Reporting

- 3 FOR the purpose of repealing certain provisions of law requiring the State Board of 4 Veterinary Medical Examiners to adopt regulations encouraging a veterinary $\mathbf{5}$ practitioner to report suspected instances of certain animal cruelty to certain 6 agencies; repealing certain provisions of law providing immunity from civil liability 7 for a veterinary practitioner who reports suspected animal cruelty to certain 8 agencies; requiring a veterinary practitioner who has reason to believe that an 9 animal that has been treated by the veterinary practitioner has been subjected to 10 cruelty or fighting in violation of certain provisions of law to report the suspected 11 animal cruelty or animal fighting to a certain law enforcement agency or county 12animal control agency in a certain manner; authorizing the Board to impose certain 13 disciplinary actions on a veterinary practitioner for failure to comply with certain 14 animal cruelty and animal fighting reporting requirements; providing immunity 15from civil liability or criminal prosecution for a veterinary practitioner who reports 16 suspected animal cruelty or animal fighting or participates in an investigation of 17suspected animal cruelty or animal fighting; and generally relating to the reporting 18 of animal cruelty and animal fighting by veterinary practitioners.

16	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17	That the Laws of Maryland read as follows:

21 (d) "License" means a license to practice veterinary medicine in the State.

22 (h) "Veterinarian" means any person who is a graduate of a college of veterinary 23 medicine.

24 (i) "Veterinary practitioner" means a licensed and registered veterinarian 25 engaged in the practice of veterinary medicine.

[(f) (1) The Board shall adopt regulations encouraging a veterinary
 practitioner to report suspected instances of animal cruelty, including suspected animal
 fighting, to a local law enforcement or county animal control agency.

HOUSE BILL 1463

1 The Board may refuse, suspend, or revoke any application or license, and censure or 2 place on probation any licensee after a hearing, if the veterinarian or veterinary 3 practitioner:

4 (10) Is determined by four members to be professionally incompetent as a 5 veterinary practitioner; [or]

6 (11) Is disciplined by a licensing authority of another state, including the 7 suspension or revocation of a license to practice veterinary medicine, for an act that would 8 be grounds for disciplinary action under this section; **OR**

9 (12) FAILS TO COMPLY WITH ANIMAL CRUELTY OR ANIMAL FIGHTING 10 REPORTING REQUIREMENTS UNDER § 2–313.1 OF THIS SUBTITLE.

12 (A) A VETERINARY PRACTITIONER WHO HAS REASON TO BELIEVE THAT AN 13 ANIMAL THAT HAS BEEN TREATED BY THE VETERINARY PRACTITIONER HAS BEEN 14 SUBJECTED TO CRUELTY OR FIGHTING IN VIOLATION OF § 10–604, § 10–606, § 15 10–607, OR § 10–608 OF THE CRIMINAL LAW ARTICLE SHALL REPORT THE 16 SUSPECTED ANIMAL CRUELTY OR ANIMAL FIGHTING TO THE APPROPRIATE LAW 17 ENFORCEMENT AGENCY OR COUNTY ANIMAL CONTROL AGENCY IN A TIMELY 18 MANNER.

19 **(B) A** VETERINARY PRACTITIONER WHO MAKES A REPORT UNDER 20 SUBSECTION (B) OF THIS SECTION SHALL INCLUDE IN THE REPORT:

- (1) THE NAME, AGE, AND LOCATION OF THE ANIMAL;

22 (2) THE NAME AND HOME ADDRESS OF THE OWNER OR CUSTODIAN OF 23 THE ANIMAL;

- 24 (3) THE LOCATION OF THE ANIMAL;
- (4) THE NATURE AND EXTENT OF THE SUSPECTED ANIMAL CRUELTY
 OR ANIMAL FIGHTING, INCLUDING ANY EVIDENCE OR INFORMATION AVAILABLE TO
 THE VETERINARY PRACTITIONER CONCERNING POSSIBLE PREVIOUS INSTANCES OF
 ANIMAL CRUELTY OR ANIMAL FIGHTING; AND

- (5) ANY OTHER INFORMATION THAT WOULD HELP DETERMINE:

30(I) THE CAUSE OF THE SUSPECTED ANIMAL CRUELTY OR31ANIMAL FIGHTING; AND

1(II)THE IDENTITY OF ANY INDIVIDUAL RESPONSIBLE FOR THE2SUSPECTED ANIMAL CRUELTY OR ANIMAL FIGHTING.

3 (C) A VETERINARY PRACTITIONER WHO REPORTS IN GOOD FAITH
 4 SUSPECTED ANIMAL CRUELTY OR ANIMAL FIGHTING OR PARTICIPATES IN AN
 5 INVESTIGATION OF SUSPECTED ANIMAL CRUELTY OR ANIMAL FIGHTING IS IMMUNE
 6 FROM:

7 (1) CIVIL LIABILITY THAT RESULTS FROM THE REPORT OR 8 PARTICIPATION IN THE INVESTIGATION; OR

9 (2) CRIMINAL PROSECUTION FOR THE REPORT OR PARTICIPATION IN 10 THE INVESTIGATION.

13 A licensed veterinary practitioner is immune from any civil liability that results 14 from:

15 (1) The actions of a licensed acupuncturist that practices in accordance 16 with 2-301(g)(11) of the Agriculture Article;

17 (2) The actions of a person that:

(i) Is licensed, certified, or otherwise authorized to practice a health
 occupation under the Health Occupations Article; and

20 (ii) Is authorized to practice the health occupation on an animal in 21 accordance with § 2–304 of the Agriculture Article; [or]

(3) A report in good faith of suspected animal cruelty OR ANIMAL
FIGHTING to a local law enforcement or county animal control agency under [§ 2–304(f)] §
24 2–313.1 of the Agriculture Article; OR

25(4) THE LICENSED VETERINARY PRACTITIONER'S PARTICIPATION IN26AN INVESTIGATION OF SUSPECTED ANIMAL CRUELTY OR ANIMAL FIGHTING AS27PROVIDED IN § 2–313.1(C) OF THE AGRICULTURE ARTICLE.
