3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Stop Tip-overs of Un5 stable, Risky Dressers on Youth Act" or the "STURDY
6 Act".

1	SEC. 2. CONSUMER PRODUCT SAFETY STANDARD TO PRO-
2	TECT AGAINST TIP-OVER OF FREE-STANDING
3	CLOTHING STORAGE UNITS.
4	(a) Free-Standing Clothing Storage Unit De-
5	FINED.—
6	(1) IN GENERAL.—In this section, the term
7	"free-standing clothing storage unit" means any
8	piece of furniture manufactured in the United States
9	or imported for use in the United States that is in-
10	tended for the storage of clothing, including fur-
11	niture items that—
12	(A) are commonly referred to as a chest,
13	door chest, chest of drawers, dresser, or bureau;
14	or
15	(B) may contain a chest, door chest, chest
16	of drawers, dresser, or bureau.
17	(2) CPSC DEFINITION.—The Consumer Prod-
18	uct Safety Commission may adjust the definition
19	under paragraph (1) if the Commission determines
20	that inclusion of additional furniture items is rea-
21	sonably necessary to protect public health and safe-
22	ty.
23	(b) Consumer Product Safety Standard Re-
24	QUIRED.—
25	(1) IN GENERAL.—Except as provided in sub-
26	section (c)(1), not later than 1 year after the date

1	of the enactment of this Act, the Consumer Product
2	Safety Commission shall—
3	(A) in consultation with representatives of
4	consumer groups, clothing storage unit manu-
5	facturers, and independent child product engi-
6	neers and experts, examine and assess the ef-
7	fectiveness of any voluntary consumer product
8	safety standards for free-standing clothing stor-
9	age units; and
10	(B) in accordance with section 553 of title
11	5, United States Code, promulgate a final con-
12	sumer product safety standard for free-standing
13	clothing storage units to protect children from
14	tip-over-related death or injury that includes—
15	(i) tests that require the use of weight
16	to simulate children up to 72 months of
17	age using the most recent anthropometric
18	data;
19	(ii) tests or testing that more closely
20	simulate real world use including to ac-
21	count for impact on clothing storage unit
22	stability of carpeting, drawers with items

in them, multiple open drawers, and dy-

namic force;

1	(iii) testing of all elething store σ
	(iii) testing of all clothing storage
2	units, including those under 30 inches in
3	height; and
4	(iv) warning requirements that—
5	(I) strengthen requirements for
6	permanency and conspicuous place-
7	ment now in ASTM F2057–17; and
8	(II) revise the message panel text
9	of ASTM F2057–17 to make more
10	understandable, consistent with typ-
11	ical clothing storage unit use, and
12	written to motivate consumer compli-
13	ance.
14	(2) TREATMENT OF STANDARD.—A consumer
15	product safety standard promulgated under para-
16	graph (1) shall be treated as a consumer product
17	safety rule promulgated under section 9 of the Con-
18	sumer Product Safety Act (15 U.S.C. 2058).
19	(c) Subsequent Rulemaking.—
20	(1) IN GENERAL.—At any time subsequent to
21	the publication of a consumer product safety stand-
22	ard under subsection (b)(1), the Consumer Product
23	Safety Commission may initiate a rulemaking, in ac-
24	cordance with section 553 of title 5, United States

1	(A) to modify the requirements of the con-
2	sumer product safety standard described in sub-
3	section $(b)(1)$; or
4	(B) to include any additional provision in
5	such consumer product safety standard that the
6	Commission determines is reasonably necessary
7	to protect public health or safety.
8	(2) TREATMENT OF RULES.—Any rule promul-
9	gated under paragraph (1) shall be treated as a con-
10	sumer product safety rule promulgated under section
11	9 of the Consumer Product Safety Act (15 U.S.C.
12	2058).
