1 Be it enacted by the Senate and House of Representa-

3 SECTION 1. REPEAL OF THE OFFICE OF FINANCIAL RE-4 SEARCH.

5 (a) IN GENERAL.—Subtitle B of title I of the Dodd6 Frank Wall Street Reform and Consumer Protection Act
7 (12 U.S.C. 5342) is hereby repealed.
