- FOR the purpose of creating a Joint Committee on Workforce Development; specifying the
 membership of the Committee; providing that members of the Committee serve at
 the pleasure of the appointing officer; providing for the appointment of cochairs of

 Committee to submit a certain report to the Governor and the General Assembly on
 or before a certain date each year; and generally relating to the Joint Committee on
 Workforce Development.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 16 That the Laws of Maryland read as follows:
- Article State Government
 2-10A-16.
 (A) THERE IS A JOINT COMMITTEE ON WORKFORCE DEVELOPMENT.
 (B) THE COMMITTEE CONSISTS OF THE FOLLOWING 10 MEMBERS:
 (1) EVE MEMBERS OF THE SENATE OF MARYLAND APPOINT

21(1) FIVE MEMBERS OF THE SENATE OF MARYLAND, APPOINTED BY22THE PRESIDENT OF THE SENATE; AND



1 (2) FIVE MEMBERS OF THE HOUSE OF DELEGATES, APPOINTED BY 2 THE SPEAKER OF THE HOUSE.

3 (C) THE MEMBERS OF THE COMMITTEE SERVE AT THE PLEASURE OF THE 4 PRESIDING OFFICER WHO APPOINTED THEM.

5 (D) THE PRESIDENT AND THE SPEAKER SHALL APPOINT A SENATOR AND A 6 DELEGATE, RESPECTIVELY, EACH TO SERVE AS COCHAIR.

8 (1) EVALUATE THE CONDITION OF MARYLAND'S PUBLIC AND 9 PRIVATE SECTOR WORKFORCE;

10 (2) MONITOR WORKFORCE SKILLS SHORTAGES;

11(3) IDENTIFYSTRATEGIESTOEXPANDEMPLOYMENT12OPPORTUNITIESANDINCREASEINCOMEFORMARYLANDERSTHROUGH13WORKFORCE SKILLS POLICIES;

14(4) MONITOR WORKFORCE EDUCATIONAL TRAINING FUNDED ON A15FEDERAL, STATE, AND LOCAL LEVEL AND IN THE PRIVATE SECTOR; AND

16 (5) REVIEW AND EVALUATE THE EFFECTIVENESS OF PROGRAMS, 17 POLICIES, AND PRACTICES, INCLUDING:

- 26 (3) THE MARYLAND APPRENTICESHIP AND TRAINING PROGRAM;
