	(2) The attorney general shall invite federal, state, and local law enforcement personnel
to	participate in the strike force to more effectively utilize their combined skills, expertise, and
re	sources.
	(3) The strike force shall focus the strike force's efforts on detecting, investigating,
de	eterring, and eradicating criminal activity, described in Subsection (1), within the state,
in	cluding organized retail crime, antitrust violations, intellectual property rights violations,
ga	ambling, and the purchase of stolen goods for the purpose of reselling the stolen goods for

	(4) In conjunction with the strike force, the Office of the Attorney General shall
