(ii) the individual waives the individual's constitutional rights after consultation with

the individual's appointed or retained attorney; and

88 (iii) the individual's appointed or retained attorney is present for the interrogation. 89 (b) Subsection [(5)(a)] (6)(a) does not apply to a juvenile probation officer, or a staff member of a detention facility, unless the juvenile probation officer or the staff member is 90 interrogating the individual on behalf of a peace officer or a law enforcement agency. 91 92 [(6)] (7) A minor may only waive the minor's right to be represented by counsel at all 93 stages of court proceedings as described in Section 78B-22-204. 94 [<del>(7)</del>] (8) If a child is subject to a custodial interrogation for an offense, a peace officer, or an individual interrogating a child on behalf of a peace officer or a law enforcement agency. 95 96 may not knowingly: 97 (a) provide false information about evidence that is reasonably likely to elicit an 98 incriminating response from the child; or 99 (b) make an unauthorized statement about leniency for the offense. (9) (a) A law enforcement agency shall make an audio recording or an audio-video 100 recording that accurately records a custodial interrogation of a child. 101 102 (b) A court shall determine whether a recorded or unrecorded custodial interrogation of a child is admissible in a prosecution of the child in accordance with Rule 616 of the Utah 103 104 Rules of Evidence.
