### A BILL

To amend title 5, United States Code, to provide for the halt in pension payments for Members of Congress sentenced for certain offenses, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "No Congressionally-
- 5 Obligated Recurring Revenue Used as Pensions To Incar-

cerated Officials Now Act" or the "No CORRUPTION 2 Act". 3 SEC. 2. FORFEITURE OF PENSION. 4 (a) In General.—Section 8332(o) of title 5, United 5 States Code, is amended— 6 (1) by redesignating paragraphs (4), (5), and 7 (6) as paragraphs (5), (6), and (7), respectively; 8 (2) by inserting after paragraph (3) the fol-9 lowing: 10 "(4)(A) Subject to subparagraph (B), an individual 11 convicted of an offense described in paragraph (2) shall 12 not be eligible to receive any payment of an annuity pursu-13 ant to the retirement system under this subchapter or chapter 84, except that this sentence applies only to such 14 15 payments based on service rendered as a Member (irrespective of when rendered). 16 17 "(B) If the conviction of an individual described in 18 subparagraph (A) is held to be invalid, the individual shall 19 receive payments that the individual would have received 20 but for the application of subparagraph (A). 21 "(C) This paragraph applies only to a conviction that 22 occurs after the date of enactment of this paragraph.";
