A BILL

- To create a publicly available lottery system for permits for the use of motorized or nonmotorized boats in the Boundary Waters Canoe Area Wilderness, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Letting Outdoor Tour-
 - 5 ism Thrive for Every Recreation Yearly Act" or the
 - 6 "LOTTERY Act".
 - 7 SEC. 2. FINDINGS.
 - 8 Congress finds the following:

1	(1) Before the 2019 season, outfitters, coopera-
2	tors, and visitors used a lottery system to obtain
3	permits for the use of motorized or nonmotorized
4	boats in the Boundary Waters Canoe Area Wilder-
5	ness.
6	(2) The lottery system described in paragraph
7	(1) was publicly available on a recreational website
8	of the Federal Government.
9	(3) The lottery system described in paragraph
10	(1) is widely supported and accepted by cooperators
11	(4) With respect to the 2019 season, the Forest
12	Service changed the lottery system to obtain permits
13	for the use of motorized or nonmotorized boats in
14	the Boundary Waters Canoe Area Wilderness.
15	(5) The system described in paragraph (4) was
16	not effective or successful.
17	(6) The Boundary Waters Canoe Area Wilder-
18	ness is an international destination for boating and
19	outdoor recreation, boasts world class fishing, camp-
20	ing, and excursion opportunities, and is a tremen-
21	dous asset to the local economies in the region.
22	SEC. 3. PERMITS IN THE BOUNDARY WATERS CANOE AREA
23	WILDERNESS.
24	Beginning January 1, 2020, the Secretary of Agri-

25 culture shall—

1	(1) carry out a lottery system to issue permits
2	for the use of motorized or nonmotorized boats in
3	the Boundary Waters Canoe Area Wilderness estab-
4	lished under Public Law 95–495 (92 Stat. 1648);
5	and
6	(2) make such lottery system publicly available
7	on a regrestion website of the Federal Government
