7 An Act relating to the State Election Board;  
8 requiring that portions of certain appropriated funds  
9 be used for certain purposes; making appropriations  
10 nonfiscal; requiring duties and compensation not  
11 otherwise required by law to be set by the Secretary  
12 of the State Election Board; and setting certain  
13 salary limitation.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. From the funds appropriated to the State Election  
16 Board in Enrolled Senate Bill No. 1922 of the 2nd Session of the  
17 57th Oklahoma Legislature, not less than One Hundred Sixty Thousand  
18 Dollars (\$160,000.00) shall be used to provide for increased  
19 compensation for precinct officials required in Enrolled Senate Bill  
20 No. 444 of the 1st Session of the 57th Oklahoma Legislature. These  
21 funds shall be used to provide additional funding for the  
22 compensation for precinct officials and shall be used to supplement  
23 rather than replace existing resources.

24 SECTION 2. From the funds appropriated to the State Election  
Board in Enrolled Senate Bill No. 1922 of the 2nd Session of the

1 57th Oklahoma Legislature, not less than Two Hundred Six Thousand  
2 Dollars (\$206,000.00) shall be used for qualified expenditures as a  
3 state match to obtain a 2020 HAVA CARES Act Grant as authorized  
4 under the Coronavirus Aid, Relief, and Economic Security (CARES) Act  
5 (Public Law 116-136).

6 SECTION 3. From the funds appropriated to the State Election  
7 Board in Enrolled Senate Bill No. 1922 of the 2nd Session of the  
8 57th Oklahoma Legislature, not less than One Million One Hundred  
9 Sixty-four Thousand Sixty-nine Dollars (\$1,164,069.00) shall be used  
10 for qualified expenditures as a state match to obtain a 2020 HAVA  
11 Election Security Grant authorized under the Consolidated  
12 Appropriations Act, 2020 (Public Law 116-93).

13 SECTION 4. Appropriations made in Enrolled Senate Bill No. 1922  
14 of the 2nd Session of the 57th Oklahoma Legislature shall not be  
15 subject to fiscal year limitations and shall be available for  
16 encumbrance and expenditure purposes for a period of thirty (30)  
17 months from the date this act is approved.

18 SECTION 5. The duties and compensation of employees not  
19 otherwise prescribed by law, necessary to perform the duties imposed  
20 upon the State Election Board by law shall be set by the Secretary  
21 of the State Election Board. For the fiscal year ending June 30,  
22 2021, and until such time as it is changed by the Legislature, the  
23 State Election Board's share of the salary of the Secretary of the  
24 State Election Board shall not exceed the salary authorized by

2 52nd Oklahoma Legislature.
