State Boat Act - Privilege to Operate a Vessel - Suspension Authority

3 FOR the purpose of authorizing the Department of Natural Resources, in addition to certain other applicable penalties, to suspend for up to a certain period of time the 4 5 privilege to operate a vessel on the waters of the State of a person who is convicted 6 of a certain violation; prohibiting a person from operating a vessel on the waters of 7 the State during a period of suspension of the privilege to operate a vessel on the 8 waters of the State; establishing certain timing and hearing requirements before the 9 suspension of the privilege to operate a vessel on the waters of the State; authorizing the Department to suspend the privilege to operate a vessel on the waters of the 10 11 State without a hearing under certain circumstances; requiring the Department to 12 adopt certain regulations; providing for the application of this Act; and generally 13 relating to the suspension of a privilege to operate a vessel on the waters of the State.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 20 That the Laws of Maryland read as follows:
- 21 Article Natural Resources
- 22 **8–738.3.**
- 23 (A) THIS SECTION APPLIES TO:

- 1 (1) A VESSEL REQUIRED TO BE REGISTERED WITH THE DEPARTMENT 2 UNDER THIS SUBTITLE;
- 3 (2) A VESSEL REQUIRED TO HAVE A VALID NUMBER AWARDED IN
- 4 ACCORDANCE WITH A FEDERAL LAW OR A FEDERALLY APPROVED NUMBERING
- 5 SYSTEM OF ANOTHER STATE; AND
- 6 (3) A VESSEL FROM A FOREIGN COUNTRY USING THE WATERS OF THE 7 STATE.
- 8 (B) THE DEPARTMENT MAY SUSPEND FOR A PERIOD NOT EXCEEDING 1
- 9 YEAR THE PRIVILEGE TO OPERATE A VESSEL ON THE WATERS OF THE STATE OF A
- 10 PERSON WHO IS CONVICTED OF OPERATING A VESSEL ON WATERS OF THE STATE
- 11 WHILE UNDER THE INFLUENCE OF ALCOHOL.
- 12 (C) (1) DURING A PERIOD OF SUSPENSION OF A PRIVILEGE TO OPERATE
- 13 A VESSEL ON THE WATERS OF THE STATE, THE PERSON WITH THE IMPOSED
- 14 SUSPENSION MAY NOT OPERATE A VESSEL ON THE WATERS OF THE STATE.
- 15 (2) A SUSPENSION IMPOSED IN ACCORDANCE WITH THIS SECTION IS
- 16 IN ADDITION TO ANY OTHER PENALTY AUTHORIZED UNDER THIS SUBTITLE.
- 17 (3) THE DEPARTMENT SHALL INITIATE ANY PROCEEDING TO
- 18 SUSPEND THE PRIVILEGE TO OPERATE A VESSEL ON THE WATERS OF THE STATE
- 19 IMMEDIATELY AFTER THE TIME FOR FILING AN APPEAL OF THE CONVICTION HAS
- 20 PASSED.
- 21 (4) (I) BEFORE THE SUSPENSION OF THE PRIVILEGE TO OPERATE
- 22 A VESSEL ON THE WATERS OF THE STATE UNDER THIS SECTION, THE DEPARTMENT
- 23 SHALL NOTIFY THE PERSON IN WRITING OF THE PERSON'S RIGHT TO A HEARING ON
- 24 REQUEST.
- 25 (II) IF A PERSON SUBMITS A WRITTEN REQUEST FOR A HEARING
- 26 TO THE DEPARTMENT WITHIN 30 DAYS AFTER THE DATE THAT THE NOTICE
- 27 REQUIRED UNDER THIS PARAGRAPH IS MAILED, THE DEPARTMENT SHALL:
- 28 1. HOLD A HEARING AFTER PROVIDING AT LEAST 10
- 29 DAYS' NOTICE TO THE PERSON; AND
- 2. CONDUCT THE HEARING IN ACCORDANCE WITH TITLE
- 31 10, SUBTITLE 2 OF THE STATE GOVERNMENT ARTICLE.

- 1 (III) THE DEPARTMENT MAY SUSPEND THE PRIVILEGE TO 2 OPERATE A VESSEL ON THE WATERS OF THE STATE WITHOUT A HEARING IF:
- THE PERSON DOES NOT SUBMIT A WRITTEN REQUEST
- 4 FOR A HEARING; OR
- 5 2. The person fails to appear for a scheduled 6 Hearing for which the Department provided notice.
- 7 (D) THE DEPARTMENT SHALL ADOPT REGULATIONS TO IMPLEMENT THIS 8 SECTION.
- 9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 October 1, 2017.
