A BILL

To designate a portion of the Arctic National Wildlife Refuge as wilderness.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION OF PORTION OF ARCTIC NA-**
2 **TIONAL WILDLIFE REFUGE AS WILDERNESS.**

3 Section 4 of the National Wildlife Refuge System Ad-
4 ministration Act of 1966 (16 U.S.C. 668dd) is amended
5 by adding at the end the following:

6 “(p) DESIGNATION OF CERTAIN LAND AS WILDER-
7 NESS.—Notwithstanding any other provision of this Act,
8 a portion of the Arctic National Wildlife Refuge in Alaska
9 comprising approximately 1,559,538 acres, as generally
10 depicted on the map entitled ‘Arctic National Wildlife Ref-
11 uge, Coastal Plain Proposed Wilderness’, dated October
12 20, 2015, labeled with Map ID 03–0172, and available
13 for inspection in the offices of the Secretary, is designated
14 as a component of the National Wilderness Preservation
15 System under the Wilderness Act (16 U.S.C. 1131 et
16 seq.).”.
