## A BILL

To amend title XVIII of the Social Security Act to prohibit the Secretary of Health and Human Services from selecting certain activities relating to the development of anti-racism plans as clinical practice improvement activities under the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Preventing Racism in  
3 Medicare Act of 2022”.

4 **SEC. 2. PROHIBITING THE SECRETARY OF HEALTH AND**  
5 **HUMAN SERVICES FROM SELECTING CER-**  
6 **TAIN ACTIVITIES RELATING TO THE DEVEL-**  
7 **OPMENT OF ANTI-RACISM PLANS AS CLIN-**  
8 **ICAL PRACTICE IMPROVEMENT ACTIVITIES**  
9 **UNDER THE MEDICARE PROGRAM.**

10 Section 1848(q)(2)(C)(v)(III) of the Social Security  
11 Act (42 U.S.C. 1395w–4(q)(2)(C)(v)(III)) is amended by  
12 adding at the end the following new sentence: “Such term  
13 does not include any activity consisting of the development  
14 of an anti-racism plan (as described in the rule entitled  
15 ‘Medicare Program; CY 2022 Payment Policies Under the  
16 Physician Fee Schedule and Other Changes to Part B  
17 Payment Policies; Medicare Shared Savings Program Re-  
18 quirements; Provider Enrollment Regulation Updates; and  
19 Provider and Supplier Prepayment and Post-Payment  
20 Medical Review Requirements’ published on November 19,  
21 2021 (86 Fed. Reg. 65969 et seq.)) or any substantially  
22 similar activity.”.
