BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 5101.33 and 5101.542 be amended	6
and section 5101.331 of the Revised Code be enacted to read as	7
follows:	8
Sec. 5101.33. (A) As used in this section, "benefits"	9
means any of the following:	10
(1) Cash assistance paid under Chapter 5107. or 5115. of	11
the Revised Code;	12
(2) Supplemental nutrition assistance program benefits	13
provided under section 5101.54 of the Revised Code;	14
(3) Any other program administered by the department of	15
job and family services under which assistance is provided or	16

service rendered;	
(4) Any other program, service, or assistance administered	18
by a person or government entity that the department determines	19
may be delivered through the medium of electronic benefit	20
transfer.	21
(B) The Subject to section 5101.331 of the Revised Code,	22
the department of job and family services may make any payment	23
or delivery of benefits to eligible individuals through the	24
medium of electronic benefit transfer by doing all of the	25
following:	26
(1) Contracting with an agent to supply debit cards to the	27
department of job and family services for use by such	28
individuals in accessing their benefits and to credit such cards	29
electronically with the amounts specified by the director of job	30
and family services pursuant to law;	31
(2) Informing such individuals about the use of the	32
electronic benefit transfer system and furnishing them with	33
debit cards and information that will enable them to access	34
their benefits through the system;	35
(3) Arranging with specific financial institutions or	36
vendors, county departments of job and family services, or	37
persons or government entities for individuals to have their	38
cards credited electronically with the proper amounts at their	39
facilities;	40
(4) Periodically preparing vouchers for the payment of	41
such benefits by electronic benefit transfer;	42
(5) Satisfying any applicable requirements of federal and	43
state law.	44

(C) The department may enter into a written agreement with	45
any person or government entity to provide benefits administered	46
by that person or entity through the medium of electronic	47
benefit transfer. A written agreement may require the person or	48
government entity to pay to the department either or both of the	49
following:	50
(1) A charge that reimburses the department for all costs	51
the department incurs in having the benefits administered by the	52
person or entity provided through the electronic benefit	53
transfer system;	54
(2) A fee for having the benefits provided through the	55
electronic benefit transfer system.	56
(D) The department may designate which counties will	57
participate in the medium of electronic benefit transfer,	58
specify the date a designated county will begin participation,	59
and specify which benefits will be provided through the medium	60
of electronic benefit transfer in a designated county.	61

(E) The department may adopt rules in accordance with	62
Chapter 119. of the Revised Code for the efficient	63

Sec. 5101.331. (A) Except as otherwise provided in this	66
section, each debit card used to access supplemental nutrition	67
assistance program benefits shall include both of the following:	68
(1) On the front of the card, a color photograph of at	69
least one adult member of the household for which the debit card	
is issued;	71
(2) On the back of the card, a telephone number that can	72
be called to report suspected fraud under the supplemental	73

nutrition assistance program and the address of a web site where	74
suspected fraud can be reported.	75
(B) Subject to division (C) of this section, both of the	76
<pre>following apply:</pre>	77
(1) All new debit cards issued on or after the date that	78
is six months after the effective date of this section shall	79
meet the requirements of division (A) of this section.	
(2) Not later than twelve months after the effective date	81
of this section, each debit card issued before the date that is	82
six months after the effective date of this section shall be	83
replaced with a debit card that meets the requirements of	84
division (A) of this section if the household for which the	85
debit card was issued continues to participate in the	86
supplemental nutrition assistance program.	87
(C) The requirement of division (A)(1) of this section	88
does not apply to a debit card issued for a household to which	
either of the following applies:	
(1) The household does not include any adult members.	91
(2) Each of the adult members of the household is sixty	92
years of age or older; is blind, disabled, or a victim of	93
domestic violence; or has religious objections to being	94

of job and family services' certification that a household	97

Code to be in immediate need of nutrition assistance is eligible	99
for the supplemental nutrition assistance program, the	100

benefit transfer card containing the amount of benefits the	103	
household is eligible to receive under the program. The card	104	
shall be sent to the member of the household in whose name	105	
application for the supplemental nutrition assistance program	106	
was made or that member's authorized representative. <u>Section</u>	107	
5101.331 of the Revised Code applies to the card.	108	
Section 2. That existing sections 5101.33 and 5101.542 of	109	
the Revised Code are hereby repealed.	110
