A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicles – Parking – Armed Forces Special Registration Plates**

3 FOR the purpose of prohibiting a political subdivision from adopting or enforcing an
4 ordinance, a regulation, or a policy that requires payment of a fee for parking a motor
5 vehicle in a parking space served by a parking meter if the motor vehicle has certain
6 armed forces–related special registration plates; and generally relating to parking
7 by motor vehicles that have certain armed forces–related special registration plates.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
24 That the Laws of Maryland read as follows:

25 **Article – Transportation**

2 (b) Subject to [subsection (c)] **SUBSECTIONS (C) AND (C–1)** of this section, any
3 State agency authorized by law and any political subdivision of this State may adopt
4 ordinances or regulations that:

5 (1) Regulate the parking of vehicles;

6 (2) Provide for the impounding of vehicles parked in violation of the
7 ordinances or regulations;

8 (3) Regulate the towing of vehicles from publicly owned and privately
9 owned parking lots; and

10 (4) Provide for the issuance of a citation by an officer for a violation of an
11 ordinance or regulation that is adopted under this section.

12 (c) A political subdivision may not adopt or enforce an ordinance or regulation
13 that prohibits the parking of more than one motorcycle within a space served by a single
14 parking meter.

15 **(C–1) A POLITICAL SUBDIVISION MAY NOT ADOPT OR ENFORCE AN**
16 **ORDINANCE, A REGULATION, OR A POLICY THAT REQUIRES PAYMENT OF A FEE FOR**
17 **PARKING A MOTOR VEHICLE IN A PARKING SPACE SERVED BY A PARKING METER IF**
18 **THE MOTOR VEHICLE HAS ONE OF THE FOLLOWING SPECIAL REGISTRATION PLATES:**

19 **(1) AN INDIVIDUALLY EARNED, COMBAT–RELATED ARMED FORCES**
20 **SPECIAL REGISTRATION PLATE ISSUED UNDER § 13–619.1 OF THIS ARTICLE; OR**

21 **(2) A DISABLED VETERAN SPECIAL REGISTRATION PLATE ISSUED BY**
22 **THE ADMINISTRATION.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2024.
