## A BILL

To increase child care options for working families and support child care providers.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Child Care Stabiliza-  
5 tion Act”.

1 **SEC. 2. CHILD CARE STABILIZATION GRANTS.**

2 (a) PURPOSES.—The purposes of this section are to  
3 make child care services more accessible for families and  
4 to support the stability and quality of child care providers  
5 by—

6 (1) promoting the stability of the child care sec-  
7 tor by providing a source of stable funding to eligible  
8 child care providers to help offset their operating ex-  
9 penses;

10 (2) supporting sustained and increased wages  
11 for early childhood educators or other staff of eligi-  
12 ble child care providers, in order to stabilize and  
13 grow the child care workforce without increasing  
14 costs for families;

15 (3) expanding the supply and capacity of eligi-  
16 ble child care providers to ensure working families  
17 have a range of high-quality, affordable child care  
18 options, in a variety of settings, that meet their  
19 unique needs; and

20 (4) supporting access to child care services for  
21 communities facing a particular shortage of child  
22 care options, including child care services for infants  
23 and toddlers, child care services during nontradi-  
24 tional or extended hours, child care services in rural  
25 communities, and inclusive child care services for  
26 children with disabilities.

1           (b) APPROPRIATION.—In addition to amounts other-  
2 wise available, there is appropriated to the Secretary of  
3 Health and Human Services, out of any money in the  
4 Treasury not otherwise appropriated to carry out the child  
5 care stabilization program established in section 2202  
6 (other than subsection (d)(2)(E) of that section) of the  
7 American Rescue Plan Act of 2021 (42 U.S.C. 9858 note)  
8 \$16,000,000,000, to remain available until expended, for  
9 each of fiscal years 2024 through 2028.

10          (c) ADMINISTRATION AND TECHNICAL ASSIST-  
11 ANCE.—The Secretary of Health and Human Services  
12 may reserve not more than 1 percent of the funding appro-  
13 priated under subsection (b) for the costs of providing  
14 technical assistance, and for the administrative costs, to  
15 carry out that section 2202.
