A BILL

To rename the Richard B. Russell National School Lunch Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Renaming the National
- 5 School Lunch Program Act of 2023".

1 SEC. 2. FINDINGS.

2	Congress finds the following:
3	(1) That Jean E. Fairfax was a civil rights ac-
4	tivist who—
5	(A) was born to parents who were the first
6	in their family to be legally free;
7	(B) fought for equitable educational ac-
8	cess, challenged systemic employment discrimi-
9	nation, and led influential federal policy innova-
10	tions in all realms to support working class and
11	marginalized peoples;
12	(C) assisted Black families navigating
13	school integration after the ruling of Brown v.
14	Board of Education;
15	(D) joined the National Association for the
16	Advancement of Colored People's Legal Defense
17	Fund and established the Division of Legal In-
18	formation and Community Service; and
19	(E) continued to serve her community
20	through civil rights work and philanthropy after
21	retirement.
22	(2) It is evidenced that Jean E. Fairfax con-
23	tributed greatly to the National School Lunch Pro-
24	gram in an equitable manner through—
25	(A) organizing five national women's orga-
26	nizations and creating the Committee on School

1	Lunch Participation to study the National
2	School Lunch Program;
3	(B) testifying before Congress on multiple
4	occasions to reveal that the implementation of
5	the National School Lunch Program was failing
6	to reach children that needed it most;
7	(C) advocating for increased funding of the
8	National School Lunch Program to serve chil-
9	dren in areas of concentrated poverty that were
10	disproportionately minorities; and
11	(D) having her findings incorporated in
12	National School Lunch Program reform legisla-
13	tion that led to the program becoming more in-
14	clusive.
15	(3) The National School Lunch Program is
16	named after an individual who—
17	(A) objected to anti-lynching bills and civil
18	rights legislation in Congress and affirmed his
19	belief in white supremacy;
20	(B) opposed school integration and was a
21	contributor to the creation of the Southern
22	Manifesto;
23	(C) dismissed concerns of child-welfare ad-
24	vocates, civil rights activists, and women-led or-
25	ganizations during debate over the implementa-

1	tion of the National School Lunch Program;
2	and
3	(D) believed that segregation should be
4	maintained while implementing the National
5	School Lunch Program.
6	SEC. 3. RENAMING OF RICHARD B. RUSSELL NATIONAL
7	SCHOOL LUNCH ACT.
8	(a) Short Title.—The first section of the Richard

11	School Lunch Act" and inserting "Jean E. Fairfax Na-
