 8 **SHED MANAGEMENT PROGRAM.**

 10 and Public Lands Management Act of 1996 (Public Law
 11 104-333; 110 Stat. 4148; 123 Stat. 1108) is amended
 12 by striking “for the 10 fiscal years beginning after the
 13 date of enactment of the Omnibus Public Land Manage-
 14 ment Act of 2009” and inserting “for fiscal year 2017
 15 and each fiscal year thereafter”.
