Mr. Ernest Boykin 1443 Kennedy Street NW Washington, DC 20011 (Ward 4)


for appointment as a consumer member of the Board of Funeral Directors, replacing Essita Duncan, to serve the remainder of an unexpired term ending March 1, 2018.
