## Baltimore City - Maryland Transit Administration - Free Ridership for State **Employees** Transit Services for Public School Students

FOR the purpose of requiring the Maryland Transit Administration to extend to employees of the Judicial Branch and the Legislative Branch of State government the application of any program, policy, or practice through which free ridership on 6 transit vehicles is offered to employees of the Executive Branch of State government provide certain services to certain students of the Baltimore City public school system; providing that services provided under this Act are limited to certain activities and a certain time period; prohibiting the Maryland Transit Administration from seeking certain fees or reimbursement; authorizing the Maryland Transit Administration to adopt certain regulations; requiring the Administration, in conjunction with Baltimore City Public Schools, to adopt 13 14 regulations that establish certain eligibility criteria for certain students for use of services provided under this Act; requiring the City of Baltimore and the Baltimore City Board of School Commissioners to submit a certain report beginning on or before a certain date, and on or before a certain date each year thereafter; providing for a delayed effective date; providing for the termination of this Act; and generally 18 relating to the Maryland Transit Administration and free ridership for State employees Baltimore City public school students.
