## A BILL

To permanently authorize the exemption of aliens working as fish processors from the numerical limitation on H–2B nonimmigrant visas.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. EXEMPTION OF ALIENS WORKING AS FISH
- 4 PROCESSORS FROM THE NUMERICAL LIMITA-
- 5 TION ON H-2B NONIMMIGRANT VISAS.
- 6 (a) IN GENERAL.—Section 214(g)(10) of the Immi-
- 7 gration and Nationality Act (8 U.S.C. 1184(g)(10)) is
- 8 amended—

1	(1) by striking "The numerical limitations of
2	paragraph (1)(B)" and inserting "(A) The numer-
3	ical limitation under paragraph (1)(B)"; and
4	(2) by adding at the end the following:
5	"(B)(i) The numerical limitation under paragraph
6	(1)(B) shall not apply to any nonimmigrant alien issued
7	a visa or otherwise provided status under section
8	101(a)(15)(H)(ii)(b) who is employed (or has received an
9	offer of employment)—
10	"(I) as a fish roe processor, a fish roe techni-
11	cian, or a supervisor of fish roe processing; or
12	"(II) as a fish processor.
13	"(ii) As used in clause (i)—
14	"(I) the term 'fish' means fresh or saltwater
15	finfish, mollusks, crustaceans, and all other forms of
16	aquatic animal life, including the roe of such ani-
17	mals, other than marine mammals and birds; and
18	$``(\Pi)$ the term 'processor' means any person en-
19	gaged in the processing of fish, including handling,
20	storing, preparing, heading, eviscerating, shucking,
21	freezing, changing into different market forms, man-
22	ufacturing, preserving, packing, labeling, dockside
23	unloading, holding, and all other processing activi-
24	ties.".

- 1 (b) Repeal.—Section 14006 of the Department of
- 2 Defense Appropriations Act, 2005 (Public Law 108–287)

3 is repealed.
