AN ACT

Making continuing appropriations for fiscal year 2021, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.

- 5 tions Act, 2021 and Other Extensions Act".

- 15 Sec. 108. Appropriations made and funds made
- 16 available by or authority granted pursuant to this Act may
- 17 be used without regard to the time limitations for submis-
- 18 sion and approval of apportionments set forth in section
- 19 1513 of title 31, United States Code, but nothing in this
- 20 Act may be construed to waive any other provision of law
- 21 governing the apportionment of funds.
- Sec. 109. Notwithstanding any other provision of
- 23 this Act, except section 106, for those programs that
- 24 would otherwise have high initial rates of operation or
- 25 complete distribution of appropriations at the beginning

- 1 of fiscal year 2021 because of distributions of funding to
- 2 States, foreign countries, grantees, or others, such high
- 3 initial rates of operation or complete distribution shall not
- 4 be made, and no grants shall be awarded for such pro-
- 5 grams funded by this Act that would impinge on final

- 24 Deficit Control Act of 1985 or as being for disaster relief

- 16 (1) to which other appropriations are not pro-
- 17 vided by this Act, but for which there is a current
- applicable TAFS that does receive an appropriation

- 9 Sec. 134. (a) Notwithstanding section 101, amounts
- 10 are provided for "General Services Administration—Ex-
- 11 penses, Presidential Transition" for necessary expenses to
- 12 carry out the Presidential Transition Act of 1963 (3
- 13 U.S.C. 102 note), at a rate for operations of \$9,900,000,
- 14 of which not to exceed \$1,000,000 is for activities author-
