# H.R.88

## AN ACT

- To modify the boundary of the Shiloh National Military Park located in Tennessee and Mississippi, to establish Parker's Crossroads Battlefield as an affiliated area of the National Park System, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

### 1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Shiloh National Mili-
- 3 tary Park Boundary Adjustment and Parker's Crossroads
- 4 Battlefield Designation Act".
- 5 SEC. 2. DEFINITIONS.
- 6 In this Act, the following definitions apply:
- 7 (1) Affiliated Area.—The term "affiliated
- 8 area" means the Parker's Crossroads Battlefield es-
- 9 tablished as an affiliated area of the National Park
- 10 System under section 4.
- 11 (2) Park.—The term "Park" means Shiloh
- National Military Park, a unit of the National Park
- 13 System.
- 14 (3) Secretary.—The term "Secretary" means
- 15 the Secretary of the Interior.
- 16 SEC. 3. AREAS TO BE ADDED TO SHILOH NATIONAL MILI-
- 17 TARY PARK.
- 18 (a) Additional Areas.—The boundary of Shiloh
- 19 National Military Park is modified to include the areas
- 20 that are generally depicted on the map entitled "Shiloh
- 21 National Military Park, Proposed Boundary Adjustment",
- 22 numbered 304/80,011, and dated July 2014, as follows:
- (1) Fallen Timbers Battlefield.
- 24 (2) Russell House Battlefield.
- 25 (3) Davis Bridge Battlefield.

- 1 (b) Acquisition Authority.—The Secretary may
- 2 acquire lands described in subsection (a) by donation, pur-
- 3 chase from willing sellers with donated or appropriated
- 4 funds, or exchange.
- 5 (c) Administration.—Any lands acquired under
- 6 this section shall be administered as part of the Park.

### 7 SEC. 4. ESTABLISHMENT OF AFFILIATED AREA.

- 8 (a) In General.—Parker's Crossroads Battlefield in
- 9 the State of Tennessee is hereby established as an affili-
- 10 ated area of the National Park System.
- 11 (b) Description.—The affiliated area shall consist
- 12 of the area generally depicted within the "Proposed
- 13 Boundary" on the map entitled "Parker's Crossroads Bat-
- 14 tlefield, Proposed Boundary", numbered 903/80,073, and
- 15 dated July 2014.
- 16 (c) Administration.—The affiliated area shall be
- 17 managed in accordance with this Act and all laws gen-
- 18 erally applicable to units of the National Park System.
- 19 (d) Management Entity.—The City of Parkers
- 20 Crossroads and the Tennessee Historical Commission
- 21 shall jointly be the management entity for the affiliated
- 22 area.
- 23 (e) Cooperative Agreements.—The Secretary
- 24 may provide technical assistance and enter into coopera-
- 25 tive agreements with the management entity for the pur-

- 1 pose of providing financial assistance with marketing,
- 2 marking, interpretation, and preservation of the affiliated
- 3 area.
- 4 (f) Limited Role of the Secretary.—Nothing in
- 5 this Act authorizes the Secretary to acquire property at
- 6 the affiliated area or to assume overall financial responsi-
- 7 bility for the operation, maintenance, or management of
- 8 the affiliated area.
- 9 (g) GENERAL MANAGEMENT PLAN.—
- 10 (1) In General.—The Secretary, in consulta-
- 11 tion with the management entity, shall develop a
- general management plan for the affiliated area.
- The plan shall be prepared in accordance with sec-
- tion 100502 of title 54, United States Code.
- 15 (2) Transmittal.—Not later than 3 years
- after the date that funds are made available for this
- 17 Act, the Secretary shall provide a copy of the com-
- 18 pleted general management to the Committee on
- 19 Natural Resources of the House of Representatives
- and the Committee on Energy and Natural Re-
- 21 sources of the Senate.
- 22 SEC. 5. PRIVATE PROPERTY PROTECTION.
- 23 (a) No Use of Condemnation.—The Secretary of
- 24 the Interior may not acquire by condemnation any land

- 1 or interests in land under this Act or for the purposes
- 2 of this Act.
- 3 (b) Written Consent of Owner.—No non-Fed-
- 4 eral property may be included in the Shiloh National Mili-
- 5 tary Park without the written consent of the owner.
- 6 (c) NO BUFFER ZONE CREATED.—Nothing in this
- 7 Act, the establishment of the Shiloh National Military
- 8 Park, or the management plan for the Shiloh National
- 9 Military Park shall be construed to create buffer zones
- 10 outside of the Park. That activities or uses can be seen,
- 11 heard, or detected from areas within the Shiloh National
- 12 Military shall not preclude, limit, control, regulate, or de-
- 13 termine the conduct or management of activities or uses
- 14 outside of the Park.
