Mr. CASEY (for himself, Ms. KLOBUCHAR, and Ms. HARRIS) introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

To establish a Federal Advisory Council to Support Victims of Gun Violence.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Resources for Victims
- 5 of Gun Violence Act of 2019".

6 SEC. 2. FINDINGS.

- 7 Congress finds the following:
- 8 (1) In the United States, approximately 100 in9 dividuals are killed with guns every day, and more
 10 than 36,000 individuals die from gun violence every

year. Approximately 100,000 more individuals sur vive gun-related injuries every year.

3 (2) The approximately 100,000 individuals who 4 survive gun-related injuries every year in the United 5 States face a lifelong process of physical and emo-6 tional healing, in addition to the heavy economic 7 costs faced by those survivors, their families and 8 communities, and society as a whole. According to a 9 recent national poll, 4 percent of adults alive in the 10 United States as of the date of the poll, or an estimated 10,000,000 people, have been shot and in-11 12 jured in their lifetimes.

13 (3) Nearly two-thirds of gun-related deaths in 14 the United States are suicides. Suicide attempts in-15 volving firearms are uniquely lethal: while less than 16 5 percent of suicide attempts not involving a firearm 17 result in death, approximately 85 percent of suicide 18 attempts involving a firearm end in death. According 19 to a 2018 report by the Department of Veterans Af-20 fairs, veterans are about 1.5 times as likely as civil-21 ians to die by suicide, and 69.4 percent of veteran 22 suicides in 2016 resulted from a firearm injury.

(4) More than one-third of gun-related deathsin the United States are homicides, and in 2010, the

1	gun homicide rate in the United States was 25.2
2	times higher than in 22 other high-income countries.
3	(5) Gun homicides in the United States occur
4	disproportionately in cities, particularly in racially
5	segregated neighborhoods with high rates of poverty.
6	Gun homicide disproportionately affects communities
7	of color, and Black Americans represent the major-
8	ity of gun homicide victims.
9	(6) More than 325 mass shootings took place in
10	the United States in 2018, and more than 1,900
11	mass shootings have taken place since the shooting
12	at Sandy Hook Elementary School in Newtown,
13	Connecticut, in 2012. 54 percent of mass shootings
14	are related to domestic or family violence.
15	(7) Firearms are the second leading cause of
16	death for children and teenagers and the first lead-
17	ing cause of death for Black children and teenagers
18	in the United States. Every year, nearly 3,000 chil-
19	dren and teenagers are shot and killed, and approxi-
20	mately 15,600 are shot and injured.
21	(8) During an average year in the United
22	States, more than 600 women are shot to death by

States, more than 600 women are shot to death by
an intimate partner, and many more women are shot
and injured by an intimate partner. Nearly
1,000,000 women in the United States who are alive

1	as of the date of enactment of this Act have been
2	shot or shot at by an intimate partner, and approxi-
3	mately 4,500,000 women alive as of that date have
4	been threatened with a gun by an intimate partner.
5	(9) More than 10,300 violent hat crimes com-
6	mitted in the United States in an average year in-
7	volve a gun, or more than 28 each day. The vast
8	majority of hate crimes are directed against commu-
9	nities of color, religious minorities, and lesbian, gay,
10	bisexual, transgender, and queer (commonly known
11	as "LGBTQ") people.

15	(E) youth violence involving firearms;
16	(F) mass shootings;
17	(G) unintentional shootings;
18	(H) non-fatal shootings; and
19	(I) threats or exposure to violent acts in-
20	volving firearms.
21	(4) VICTIM OF GUN VIOLENCE.—The term "vic-
22	tim of gun violence" means—
23	(A) an individual who has been wounded
24	as a result of gun violence;

2	with an act of gun violence;
3	(C) an individual who has witnessed an act
4	of gun violence; and
5	(D) a relative, classmate, coworker, or

21	SEC. 4. ADVISORY COUNCIL TO SUPPORT VICTIMS OF GUN
22	VIOLENCE.
23	(a) ESTABLISHMENT.—There is established an Advi-
24	sory Council to Support Victims of Gun Violence.
25	(b) Membership.—

1	(1) IN GENERAL.—The Advisory Council shall
2	be composed of the following members or their des-
3	ignees:
4	(A) The Secretary of Health and Human
5	Services.
6	(B) The Attorney General.
7	(C) The Secretary of Education.
8	(D) The Secretary of Housing and Urban
9	Development.
10	(E) The Secretary of Veterans Affairs.
11	(F) The Commissioner of the Social Secu-
12	rity Administration.
13	(G) The Assistant Secretary for Mental
14	Health and Substance Use.
15	(H) The Director of the Centers for Dis-
16	ease Control and Prevention.
17	(I) The Director of the National Institutes
18	of Health.
19	(J) The Administrator of the Administra-
20	tion for Community Living.
21	(K) The Director of the Office on Violence
22	Against Women.
23	(L) The Director of the Office for Victims
24	of Crime.

1	(M) The chairman of the Board of the
2	Legal Services Corporation.
3	(N) As appropriate, the head of any other
4	Federal department or agency identified by the
5	Secretary of Health and Human Services as
6	having responsibilities, or administering pro-
7	grams, relating to issues affecting victims of
8	gun violence.
9	(2) Additional members.—In addition to the
10	members described in paragraph (1), the Advisory
11	Council shall be composed of the following:
12	(A) Not fewer than 2 and not more than
13	5 victims of gun violence, who shall be ap-
14	pointed by the Secretary of Health and Human
15	Services.
16	(B) Not fewer than 2 and not more than
17	5 victim assistance professionals, who shall be
18	appointed by the Secretary of Health and
19	Human Services.
20	(3) LEAD AGENCY.—The Department of Health
21	and Human Services shall be the lead agency for the
22	Advisory Council.
23	(c) DUTIES.—
24	(1) Assessment.—The Advisory Council
25	shall—

1	(A) survey victims of gun violence and vic-
2	tim assistance professionals about their needs
3	in order to inform the content of information
4	disseminated under paragraph (2) and the re-
5	port published under paragraph (3);
6	(B) conduct a literature review and assess
7	past or ongoing programs designed to assist vic-
8	tims of gun violence or individuals with similar
9	needs to determine—
10	(i) the effectiveness of the programs;
11	and
12	(ii) best and promising practices for
13	assisting victims of gun violence; and
14	(C) assess the administration of compensa-
15	tion funds established after mass shootings to
16	determine best and promising practices to di-
17	rect victims of gun violence to sources of fund-
18	ing.
19	(2) INFORMATION.—
20	(A) IN GENERAL.—The Advisory Council
21	shall identify, promote, coordinate, and dissemi-
22	nate to the public information, resources, and
23	best and promising practices available to help
24	victims of gun violence—

- 1 (i) meet their medical, financial, edu-2 cational, workplace, housing, transportation, assistive technology, and accessi-3 4 bility needs; (ii) maintain their mental health and 5 6 emotional well-being; 7 (iii) seek legal redress for their inju-8 ries and protection against any ongoing 9 threats to their safety; and 10 (iv) access government programs, 11 services, and benefits for which they may 12 be eligible or to which they may be enti-13 tled. 14 (B) CONTACT INFORMATION.—The Advi-15 sory Council shall include in the information 16 disseminated under subparagraph (A) the 17 websites and telephone contact information for 18 helplines of relevant Federal agencies, State 19 agencies, and nonprofit organizations. 20 (C) AVAILABILITY.—The Advisory Council 21 shall make the information described in sub-22 paragraphs (A) and (B) available— 23 (i) online through a public website;

and

(ii) by submitting a hard copy and 1 2 making available additional hard copies 3 to----4 (I) each Member of Congress; (II) each field office of the Social 5 6 Security Administration; 7 (III) each State agency that is responsible for administering health 8 9 and human services, for dissemination 10 to medical facilities; 11 (IV) each State agency that is re-12 sponsible for administering education 13 dissemination programs, for to 14 schools; and 15 (V) the office of each State attor-16 ney general, for dissemination to local 17 prosecutor's offices. 18 (3) REPORT.—Not later than 180 days after 19 the date of enactment of this Act, the Advisory 20 Council shall— 21 (A) prepare a report that— 22 (i) includes the best and promising 23 practices, resources, and other useful infor-24 mation for victims of gun violence identi-25 fied under paragraph (2);

1	(ii) identifies any gaps in items de-
2	scribed in clause (i); and
3	(iii) if applicable, identifies any addi-
4	tional Federal or State legislative authority
5	necessary to implement the activities de-
6	scribed in clause (i) or address the gaps
7	described in clause (ii);
8	(B) submit the report prepared under sub-
9	paragraph (A) to—
10	(i) the appropriate committees;
11	(ii) each State agency that is respon-
12	sible for administering health and human
13	services;
14	(iii) each State agency that is respon-
15	sible for administering education pro-
16	grams; and
17	(iv) the office of each State attorney
18	general; and
19	(C) make the report prepared under sub-
20	paragraph (A) available to the public online in
21	an accessible format.
22	(4) Follow-up report.—Not later than 2
23	years after the date on which the Advisory Council
24	prepares the report under paragraph (3), the Advi-
25	sory Council shall—

1	(A) submit to the entities described in sub-
2	paragraph (B) of that paragraph a follow-up re-
3	port that includes the information identified in
4	subparagraph (A) of that paragraph; and
5	(B) make the follow-up report described in
6	subparagraph (A) available to the public online
7	in an accessible format.
8	(5) Public input.—
9	(A) IN GENERAL.—The Advisory Council
10	shall establish a process to collect public input
11	to inform the development of, and provide up-
12	dates to, the best and promising practices, re-
13	sources, and other information described in
14	paragraph (2), including by conducting out-
15	reach to entities and individuals described in
16	subparagraph (B) of this paragraph that—
17	(i) have a range of experience with the
18	types of gun violence described in section
19	3(3); and
20	(ii) include representation from com-
21	munities disproportionately affected by gun
22	violence.
23	(B) ENTITIES AND INDIVIDUALS.—The en-
24	tities and individuals described in this subpara-
25	graph are—

1	(i) States, local governments, and or-
2	ganizations that provide information to, or
3	support for, victims of gun violence;
4	(ii) victims of gun violence; and
5	(iii) victim assistance professionals.
6	(C) NATURE OF OUTREACH.—In con-
7	ducting outreach under subparagraph (A), the
8	Advisory Council shall ask for input on—
9	(i) information, resources, and best
10	and promising practices available, includ-
11	ing identification of any gaps and unmet
12	needs;
13	(ii) recommendations that would help
14	victims of gun violence—
15	(I) better meet their medical, fi-
16	nancial, educational, workplace, hous-
17	ing, transportation, assistive tech-
18	nology, and accessibility needs;
19	(II) maintain their mental health
20	and emotional well-being;
21	(III) seek legal redress for their
22	injuries and protection against any
23	ongoing threats to their safety; and
24	(IV) access government pro-
25	grams, services, and benefits for

1	which the victims may be eligible or to
2	which the victims may be entitled; and
3	(iii) any other subject areas discovered
4	during the process that would help victims
5	of gun violence.
6	(d) FACA.—The Federal Advisory Committee Act (5
7	U.S.C. App.) shall not apply to the Advisory Council.
8	(e) FUNDING.—No additional funds are authorized to
9	be appropriated to carry out this Act.
10	(f) SUNSET.—The Advisory Council shall terminate
11	on the date that is 5 years after the date of establishment
12	of the Advisory Council.
