- FOR the purpose of establishing the Workgroup on Funding for a Low- or No-Interest
 Mortgage Program within the Joint Committee on Ending Homelessness; providing
 for the composition of the Workgroup; requiring the Workgroup to explore certain
 matters; requiring the Workgroup to report its findings and recommendations to the
 Joint Committee on Ending Homelessness on or before a certain date; providing for
 the termination of this Act; and generally relating to the Workgroup on Funding for
 a Low- or No-Interest Mortgage Program.
- 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 11 That:
- 12 (a) There is a Workgroup on Funding for Low- or No-Interest Mortgage Program 13 within the Joint Committee on Ending Homelessness.
- 14 (b) The Workgroup consists of representatives from:
- 15 (1) the Department of Housing and Community Development, selected by 16 the Secretary of Housing and Community Development; and
- 17 (2) the Department of Human Services, selected by the Secretary of 18 Human Services; and
- 19 (3) the following entities, selected jointly by the Secretary of Housing and 20 Community Development and the Secretary of Human Services:
- 21 (i) participating banks;
- 22 (ii) participating realtors, selected by the Secretary of Housing and Community Development and the Secretary of Human Services jointly;
